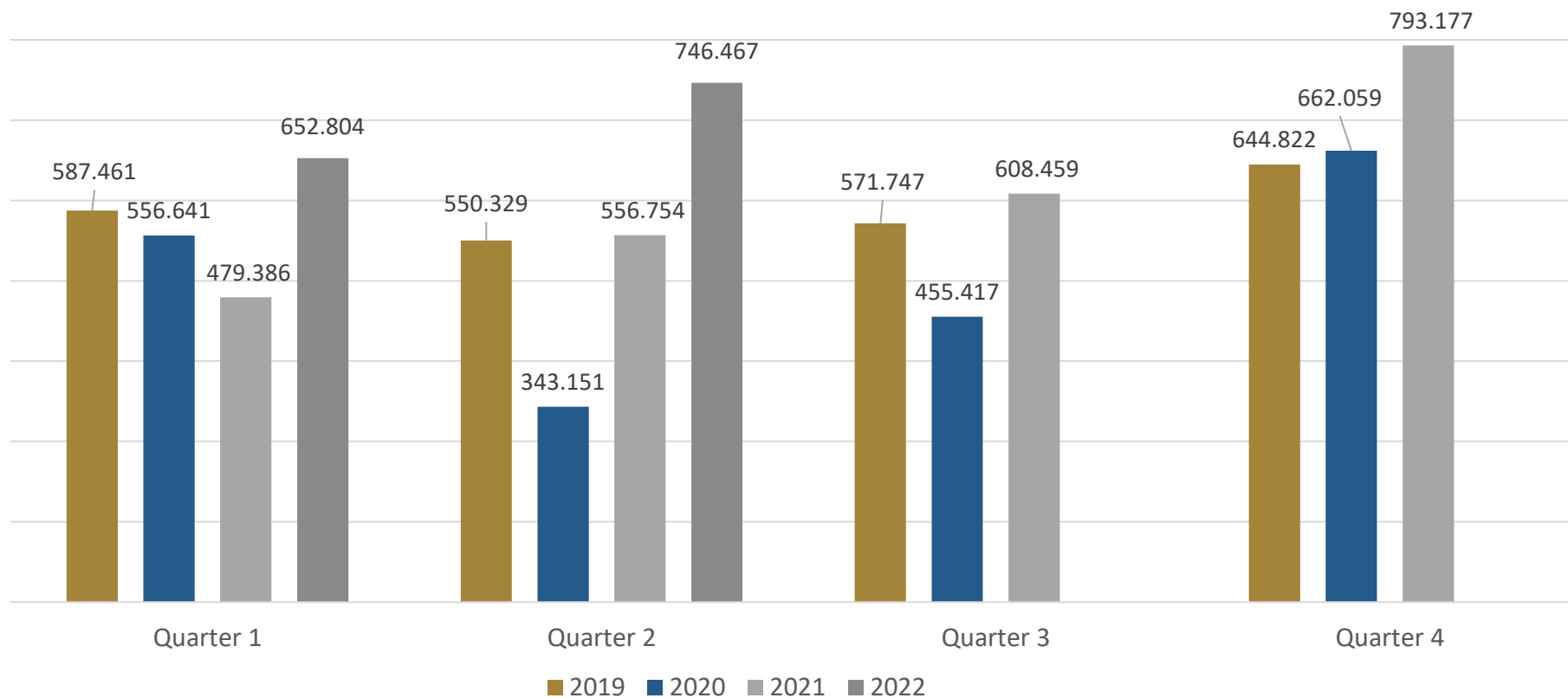

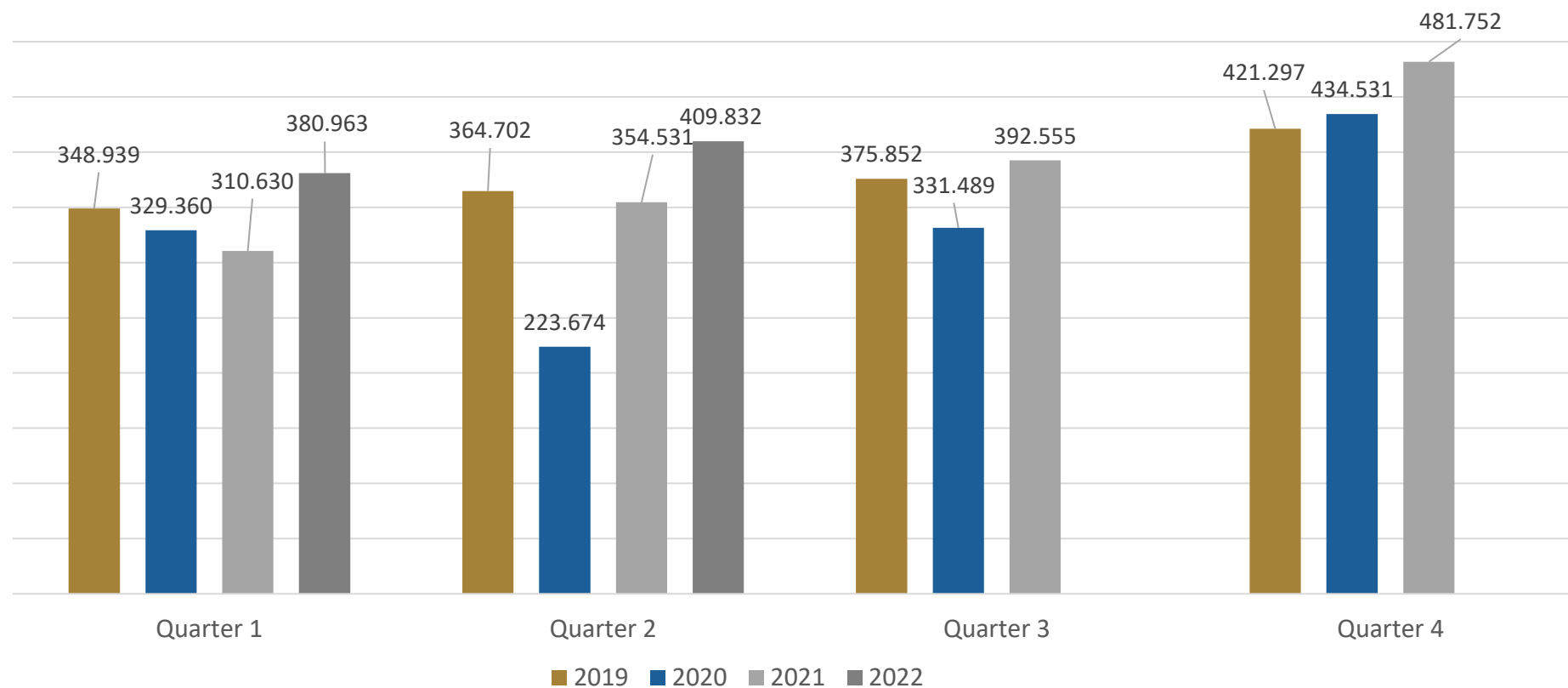

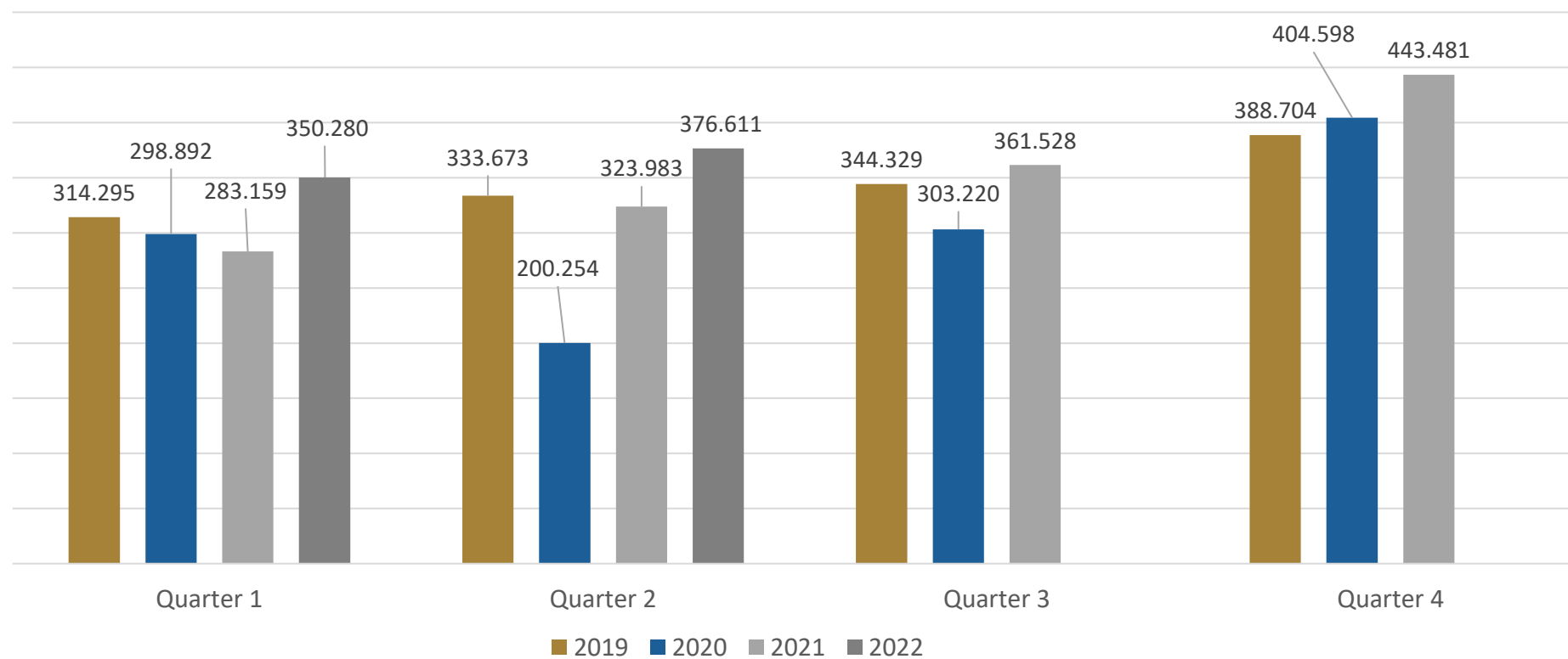

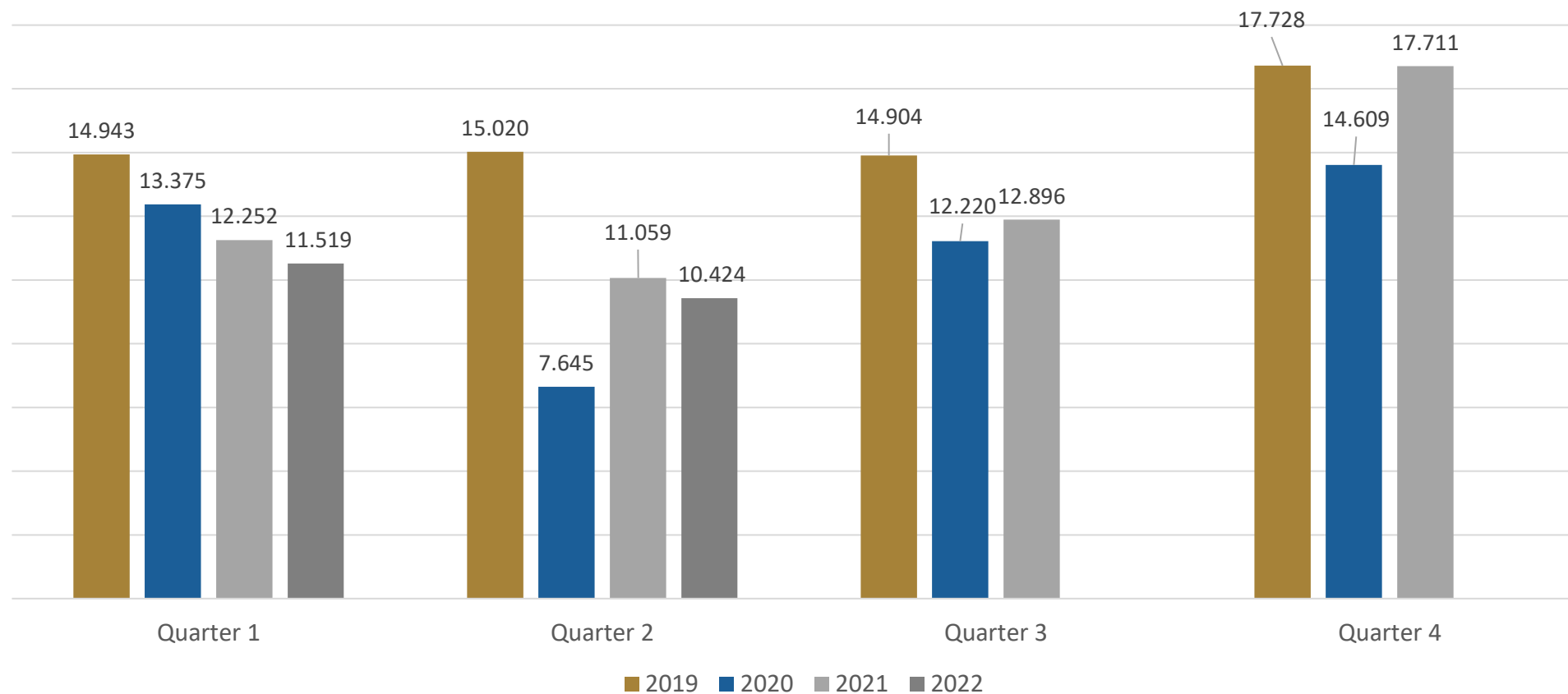

Export Clocks¹

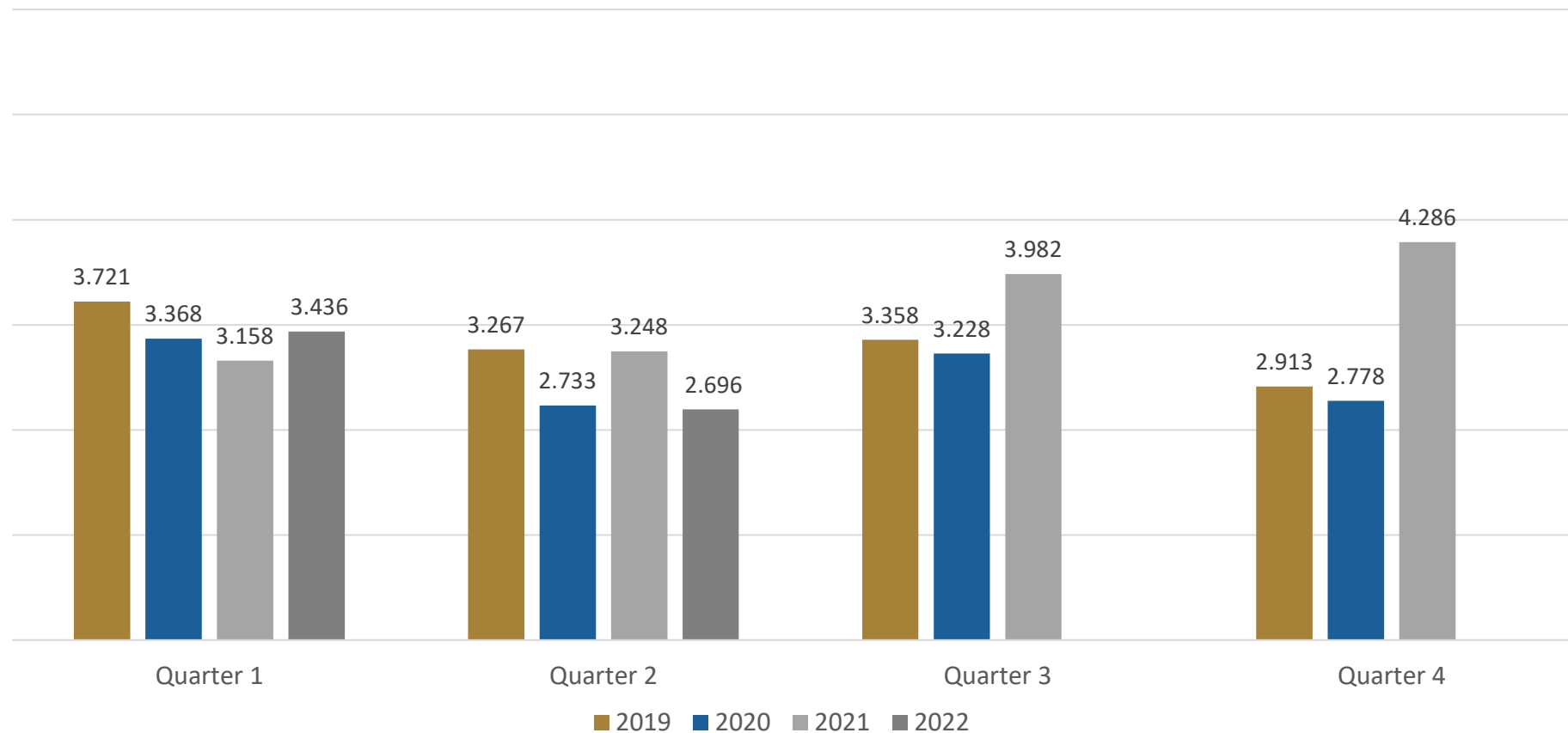

Export Watch Movements¹

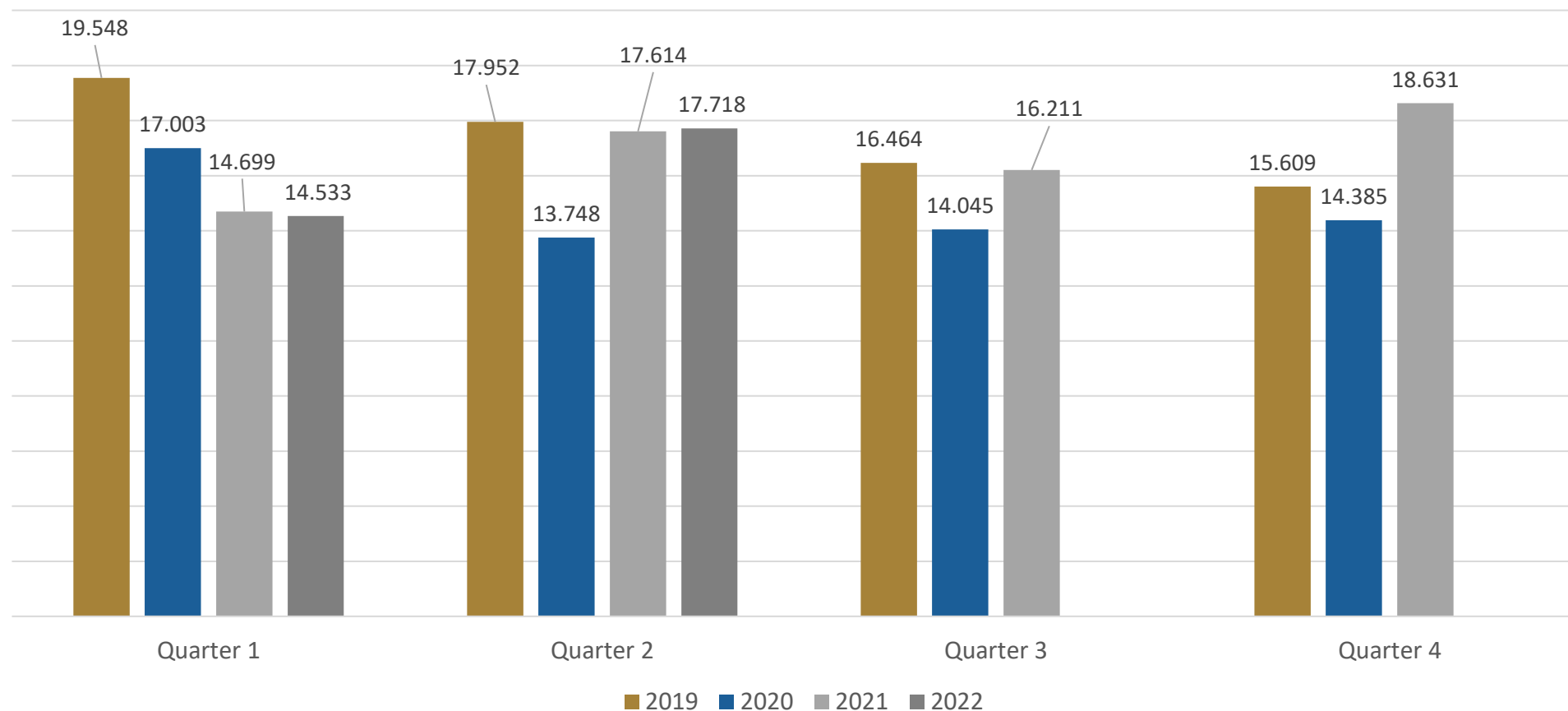

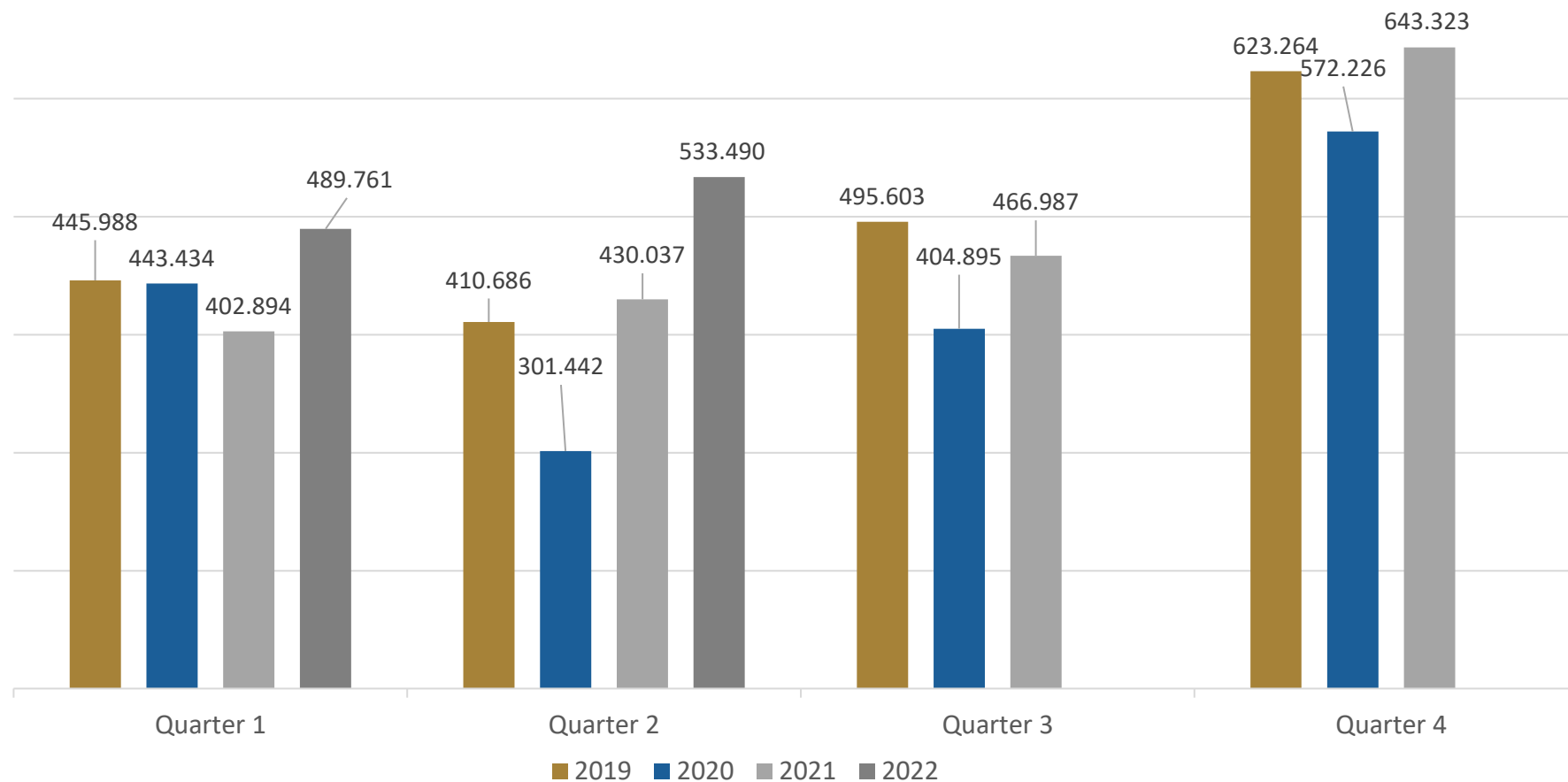

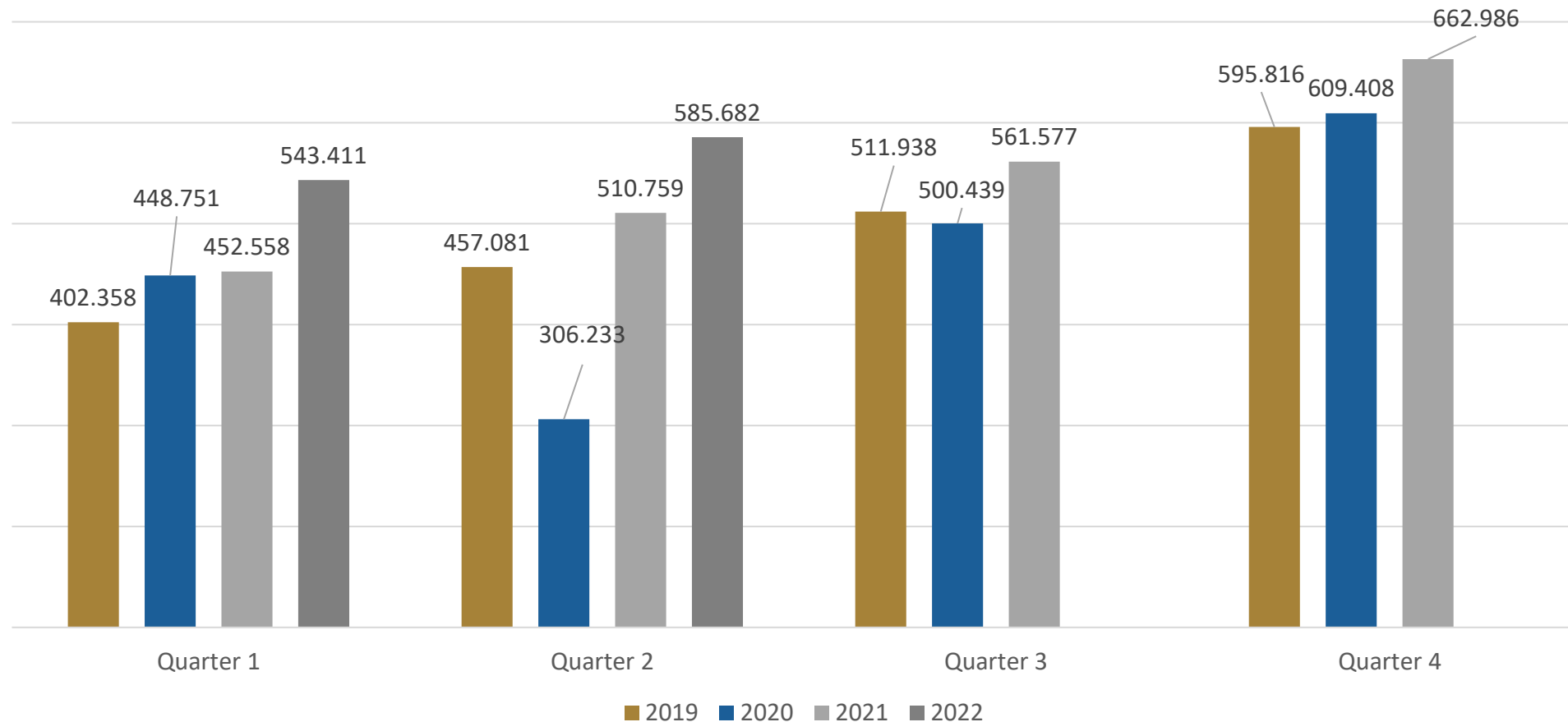

Import Watches, Clocks and Parts¹

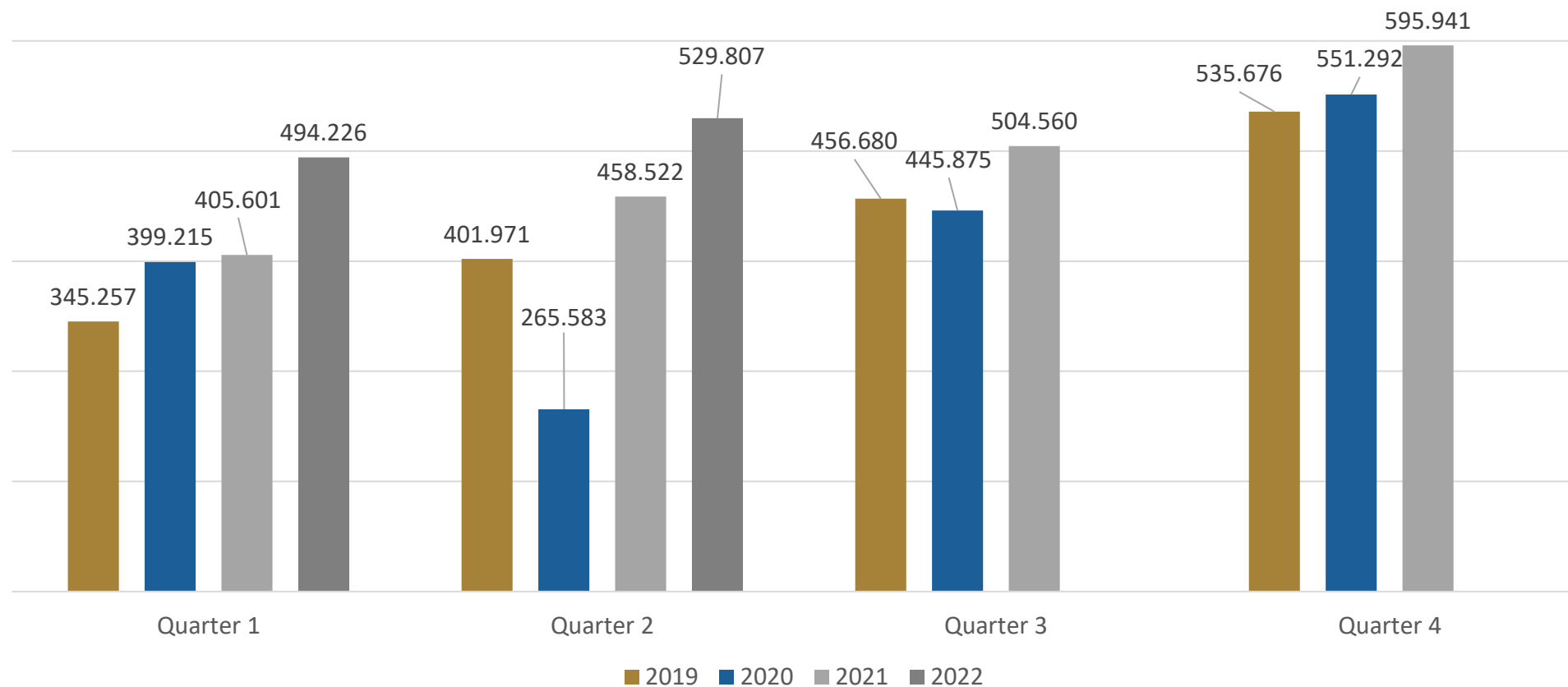

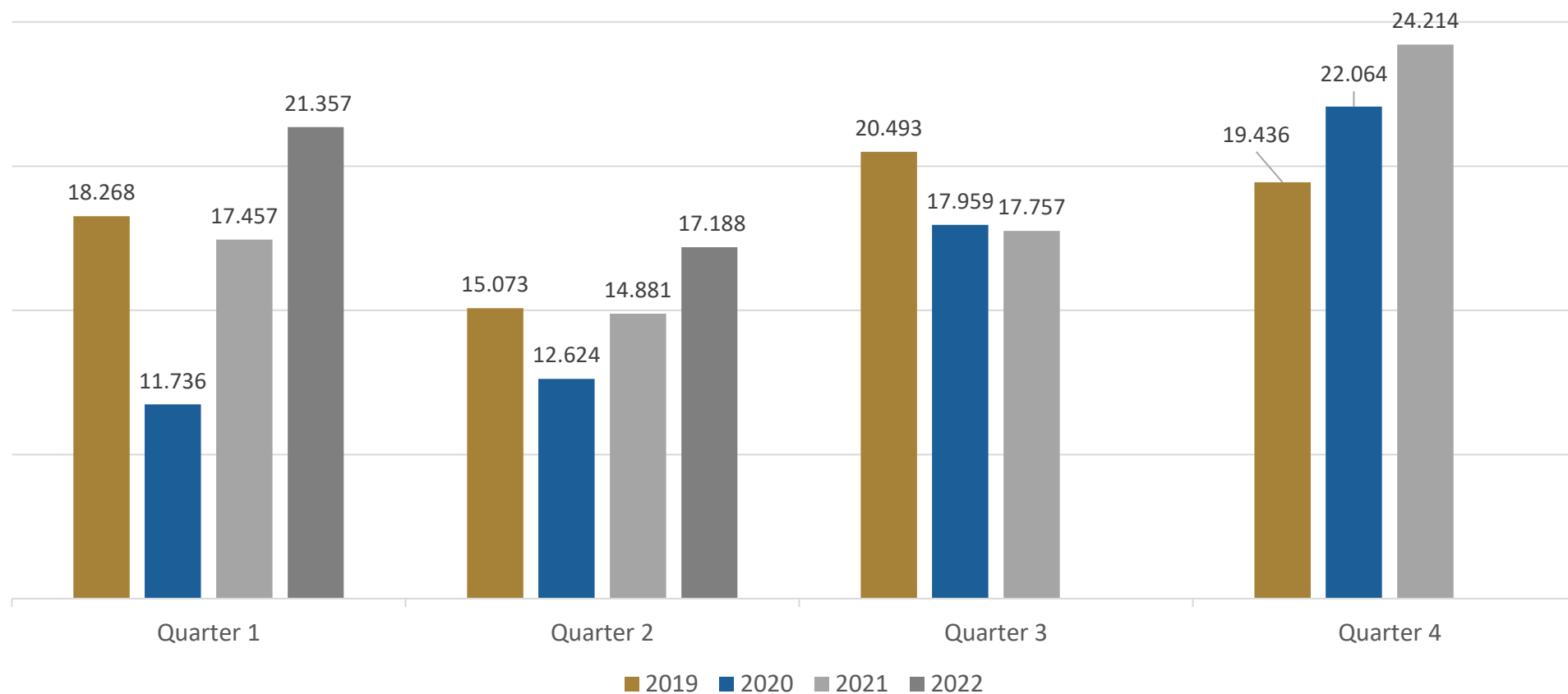

Import Clocks¹

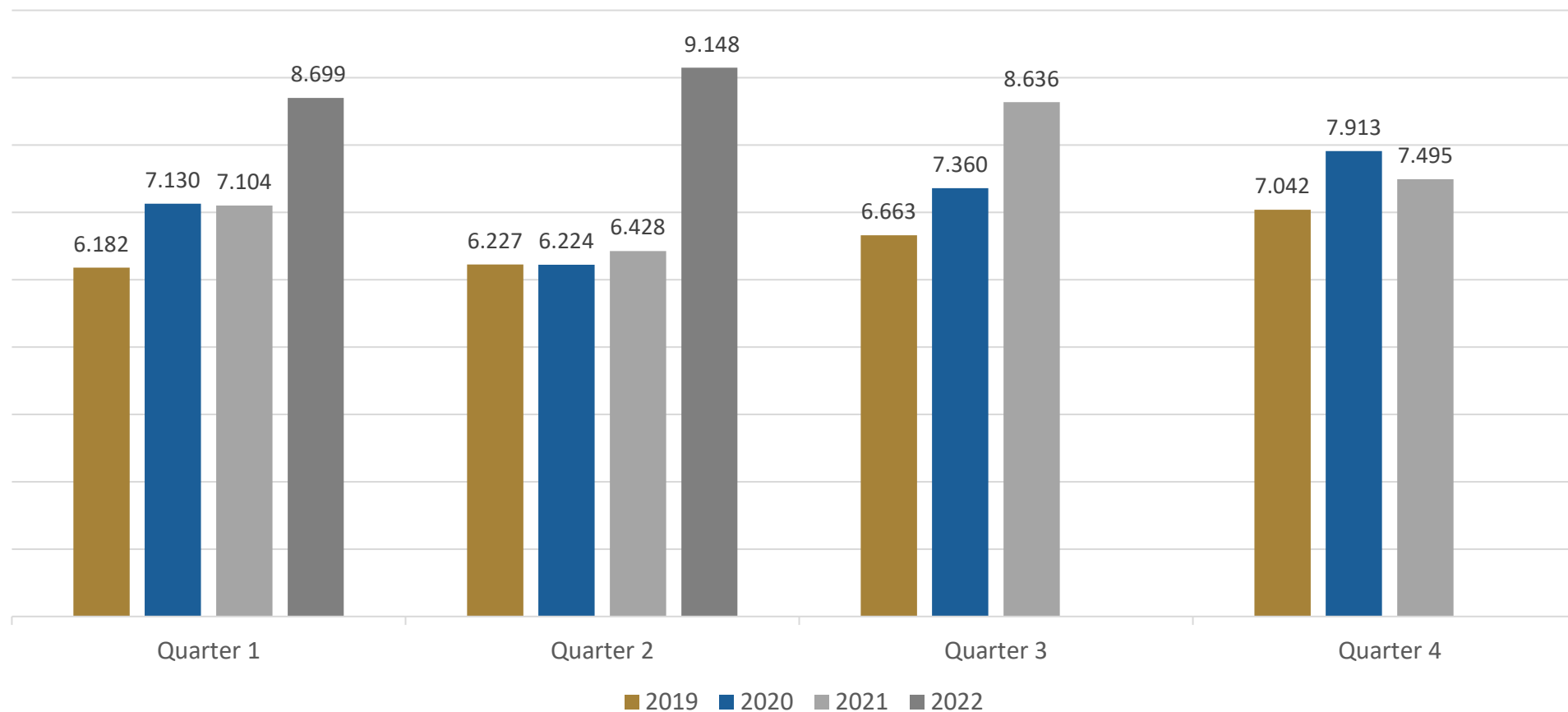

Import Watch Movements¹

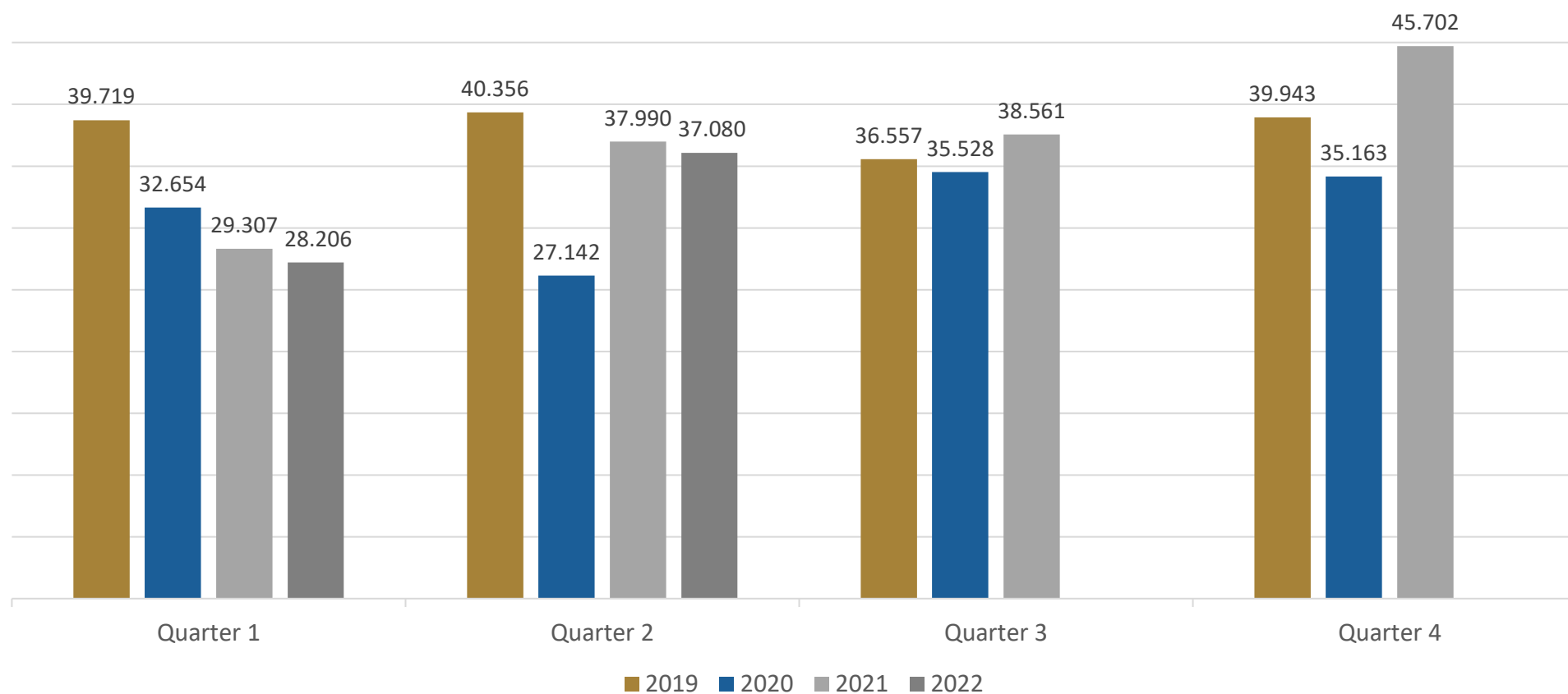
