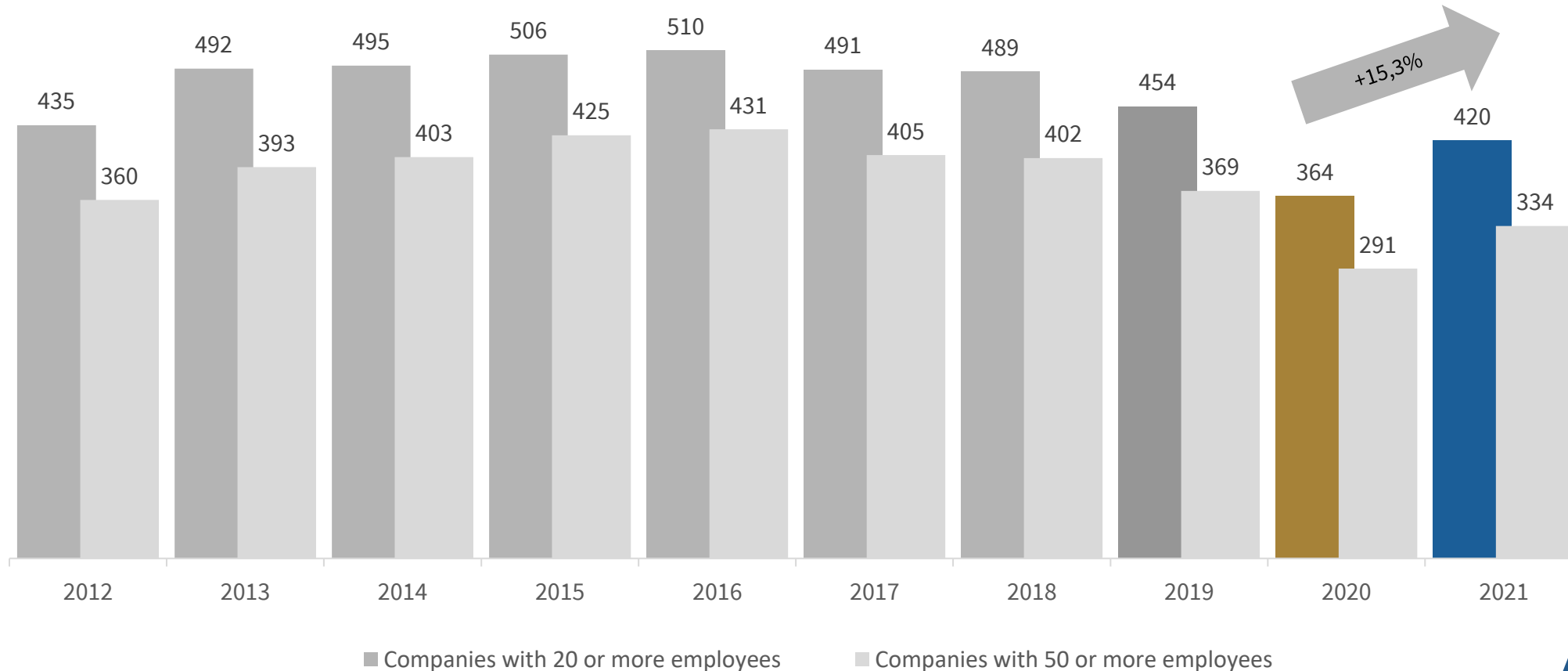

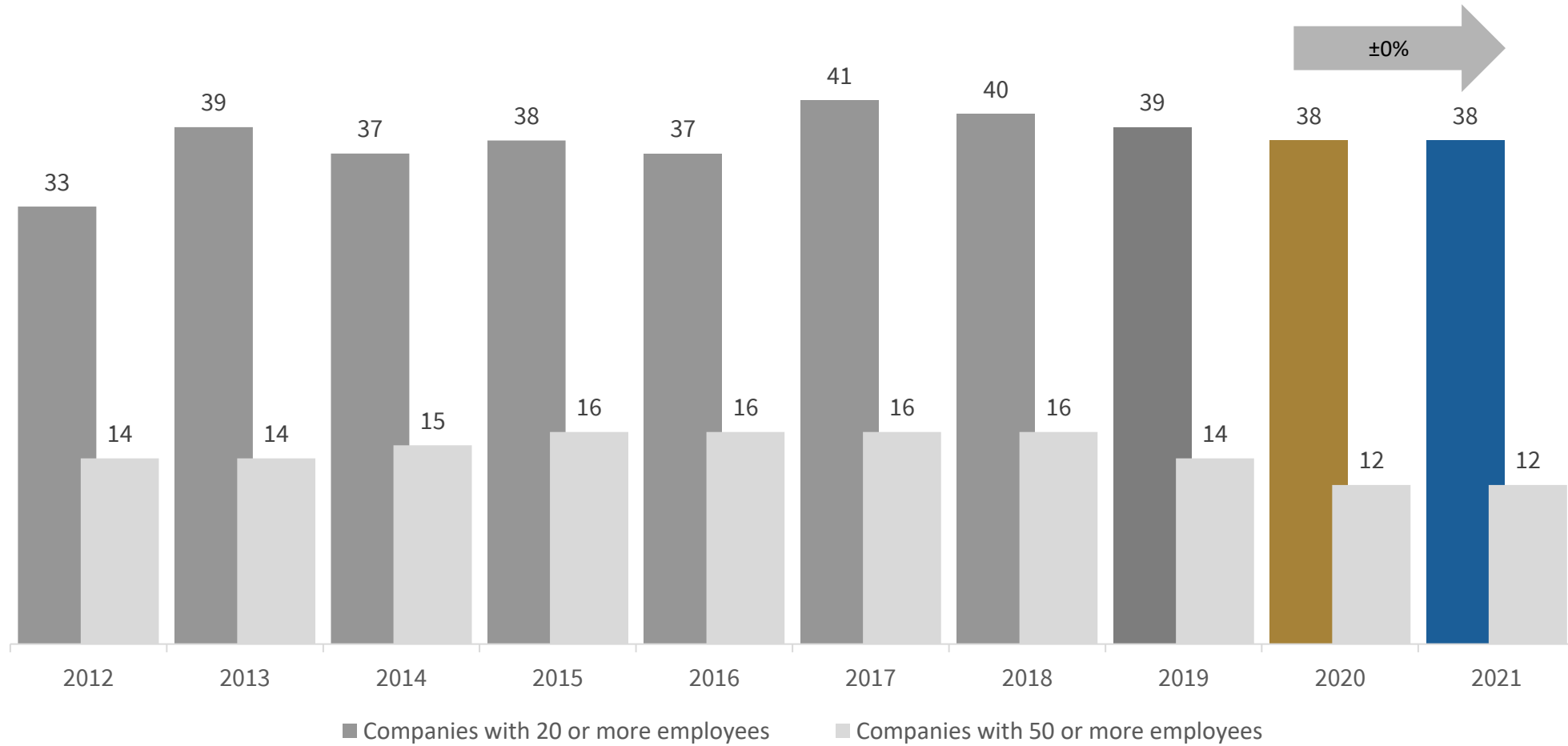

Turnover watches, clocks and parts in million Euro

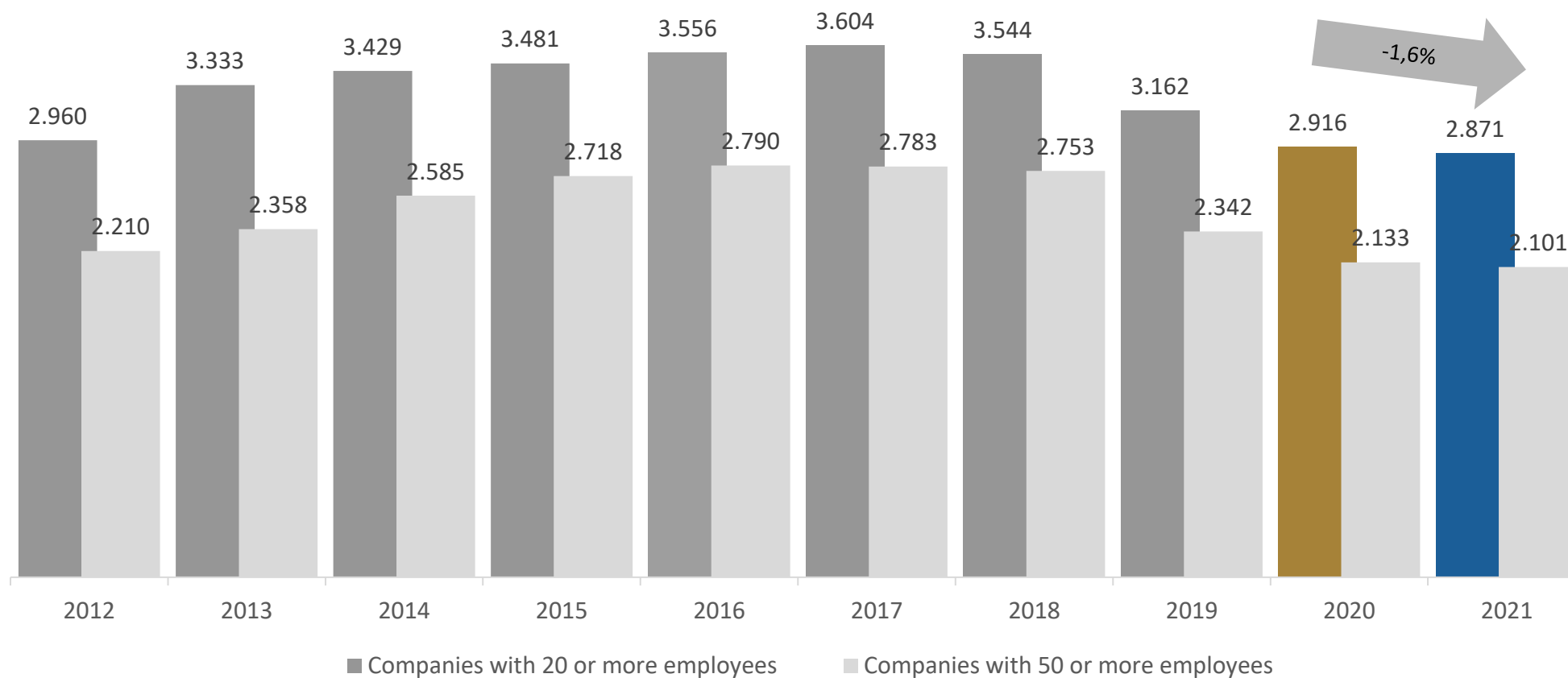


Number of Companies ¹

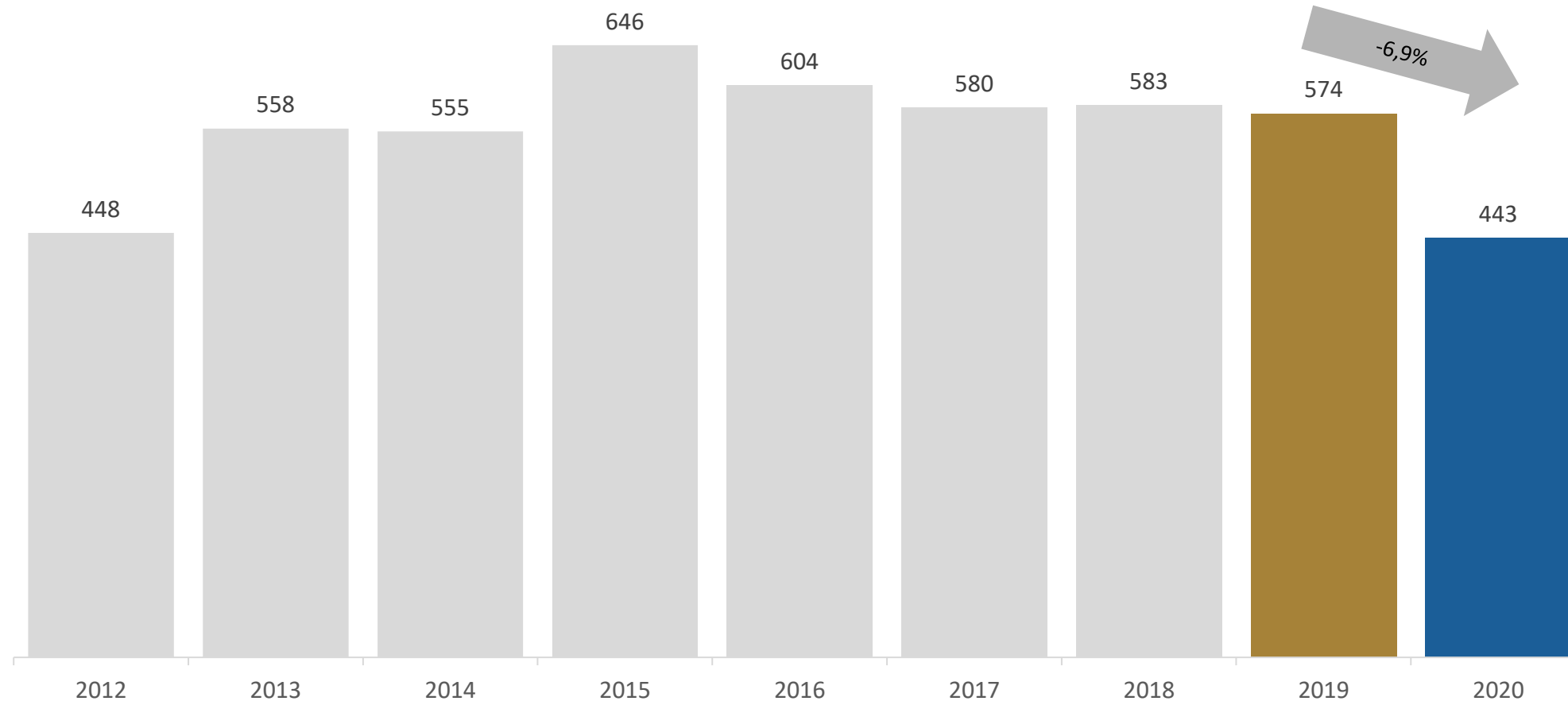

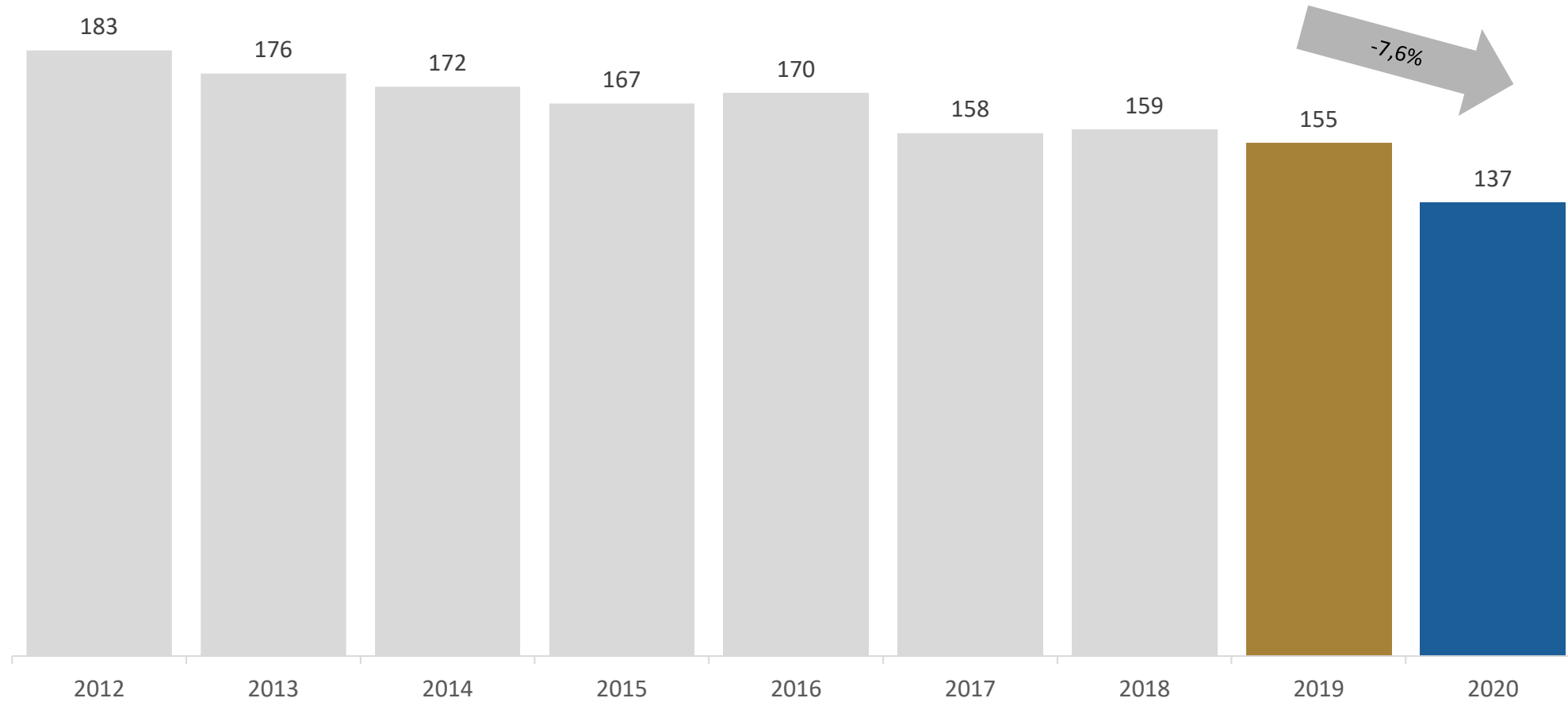

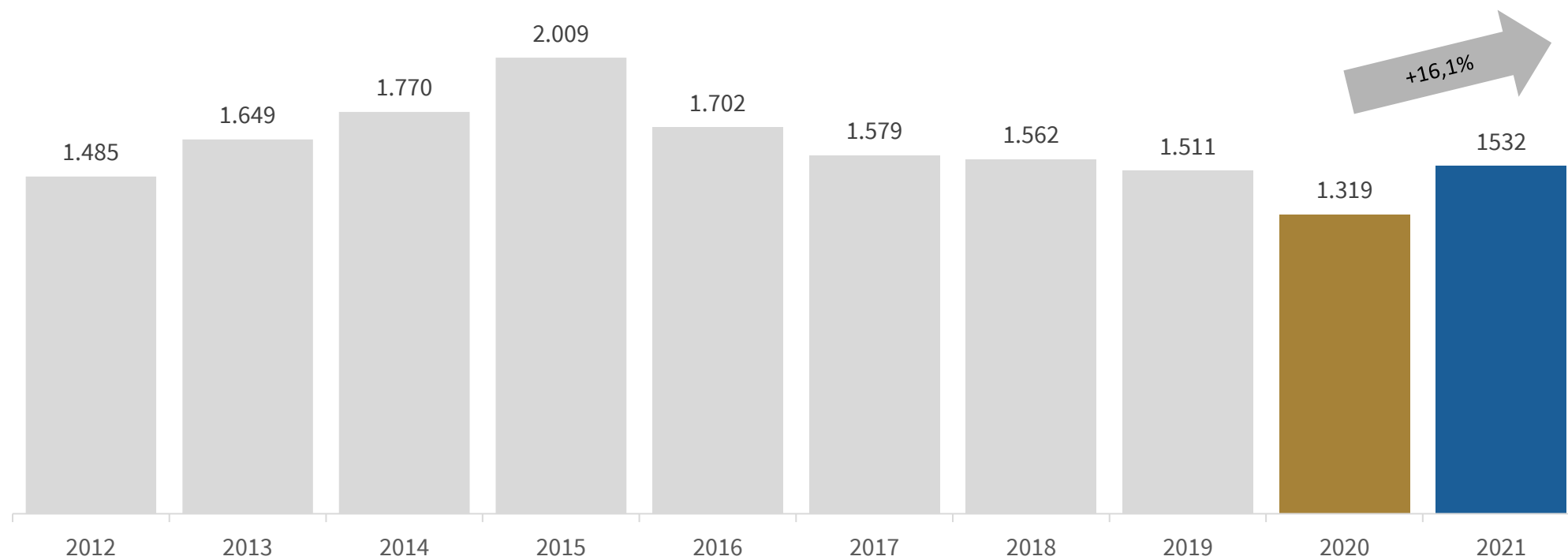

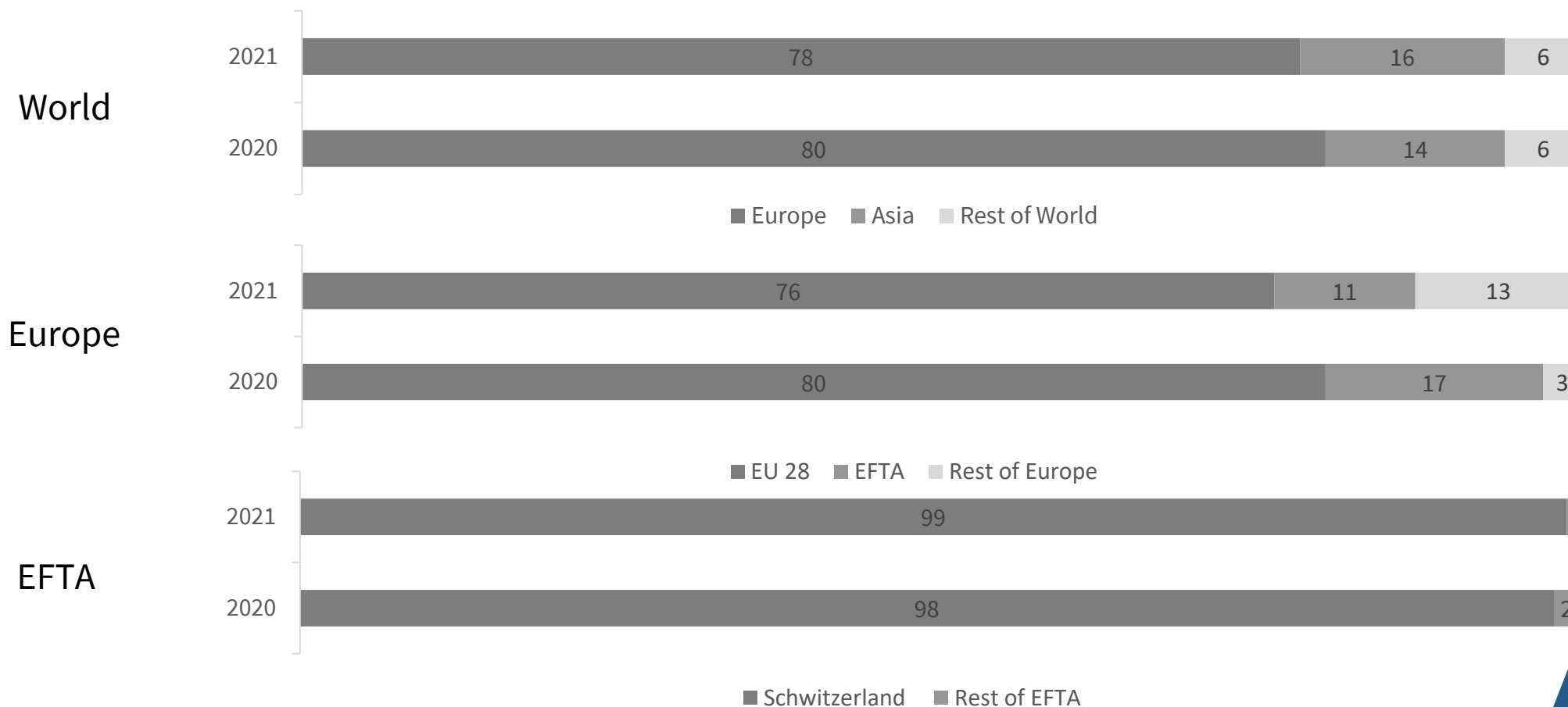

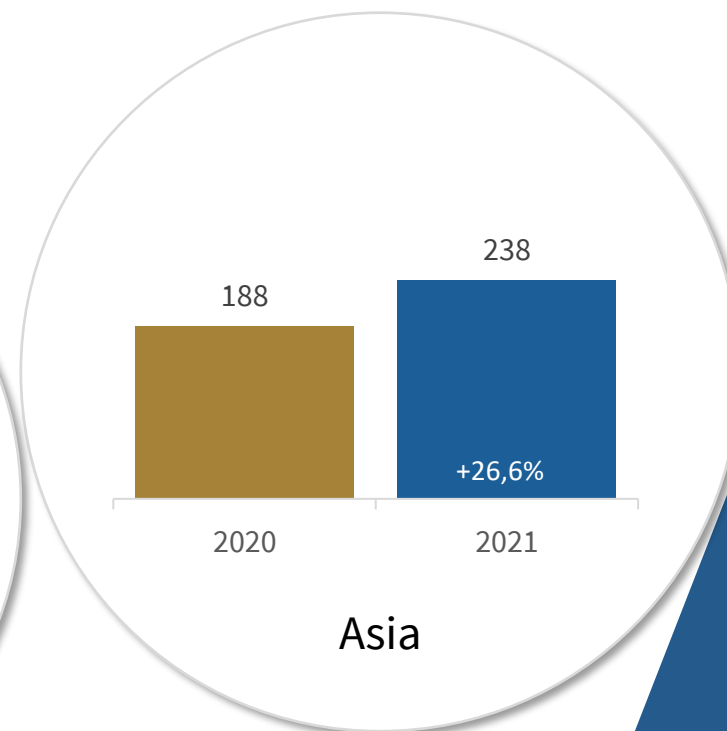
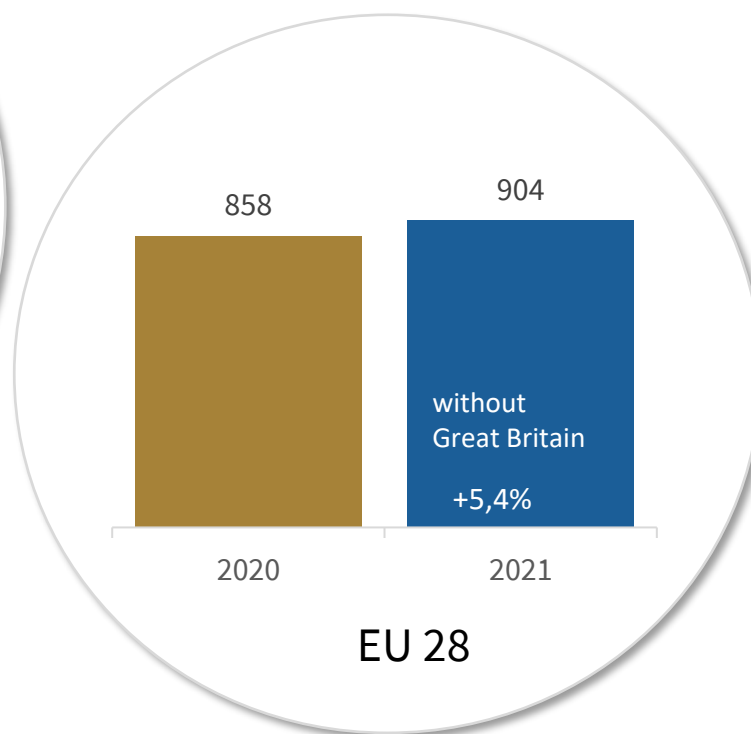
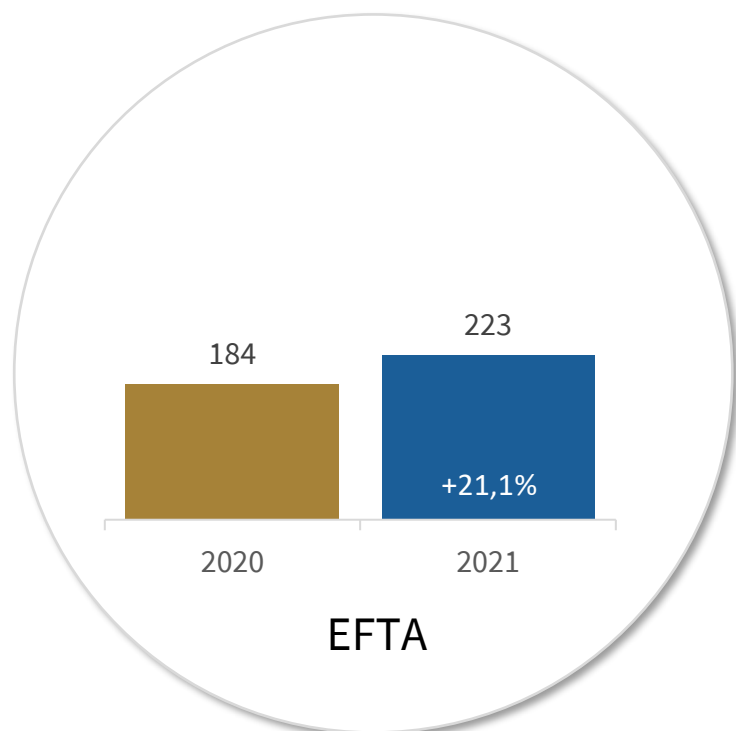
Exports of watches, clocks and parts² in million Euro



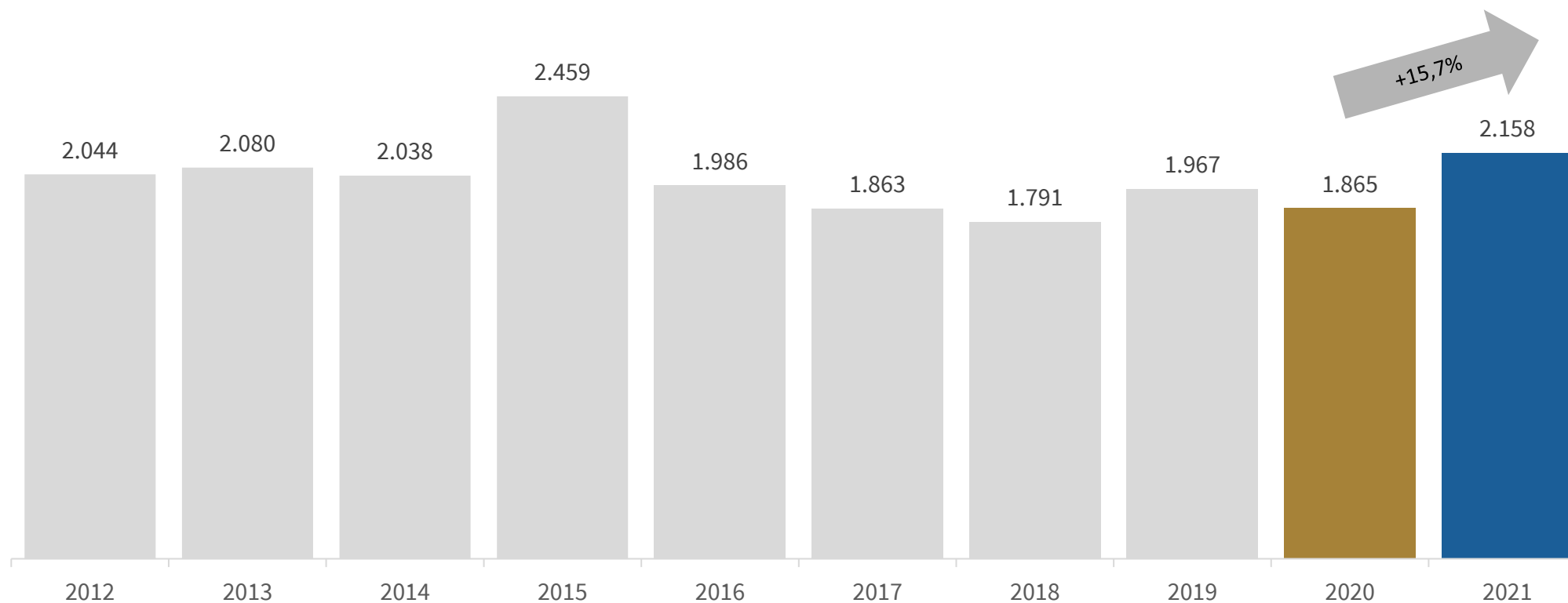
Exports of watches, clocks and parts by region² as a percentage of the total export value



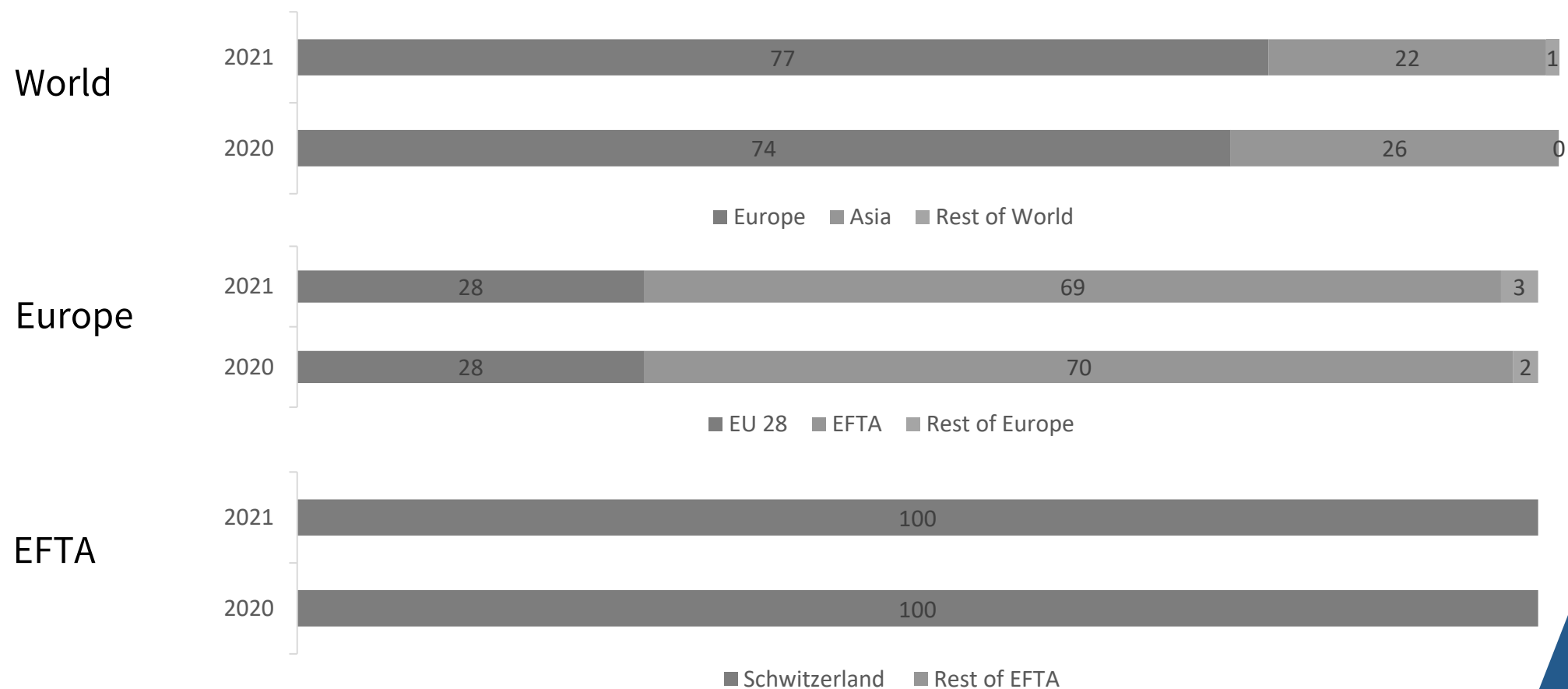
Exports of watches, clocks and parts by region² in million Euro



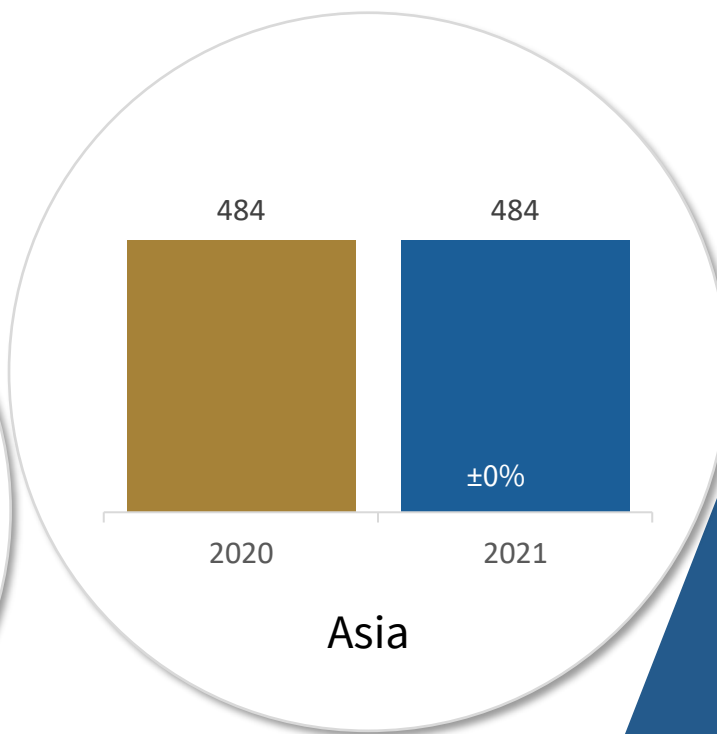
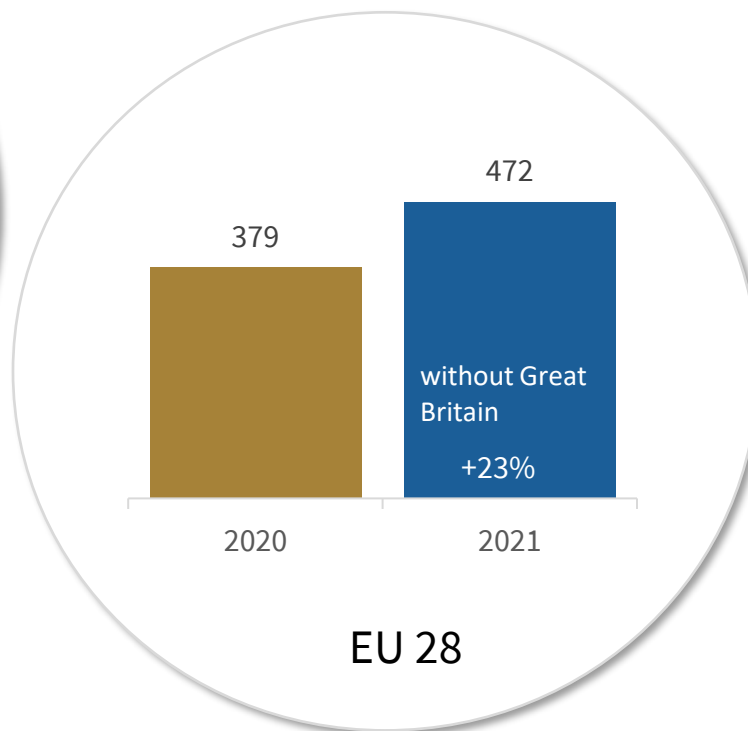
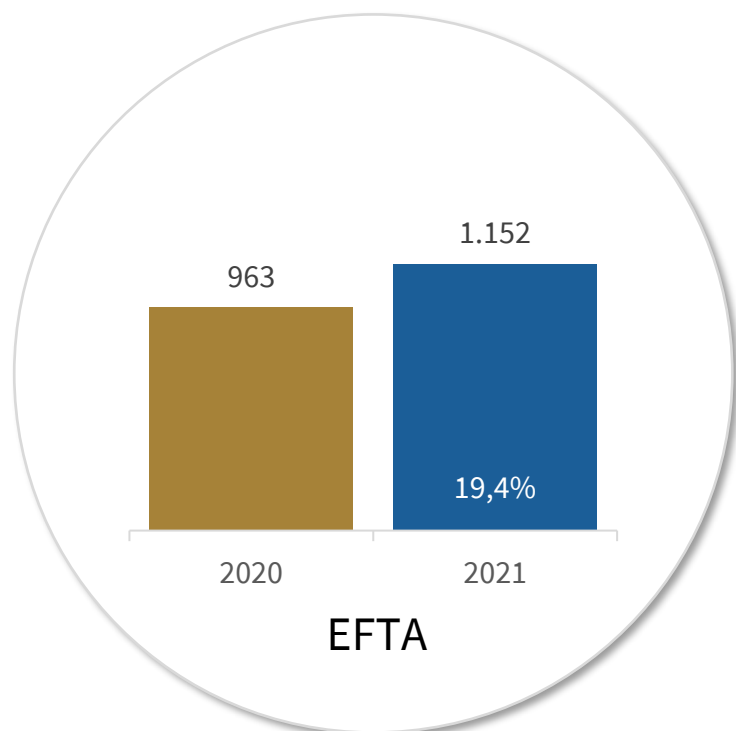
Imports of watches, clocks and parts² in million Euro



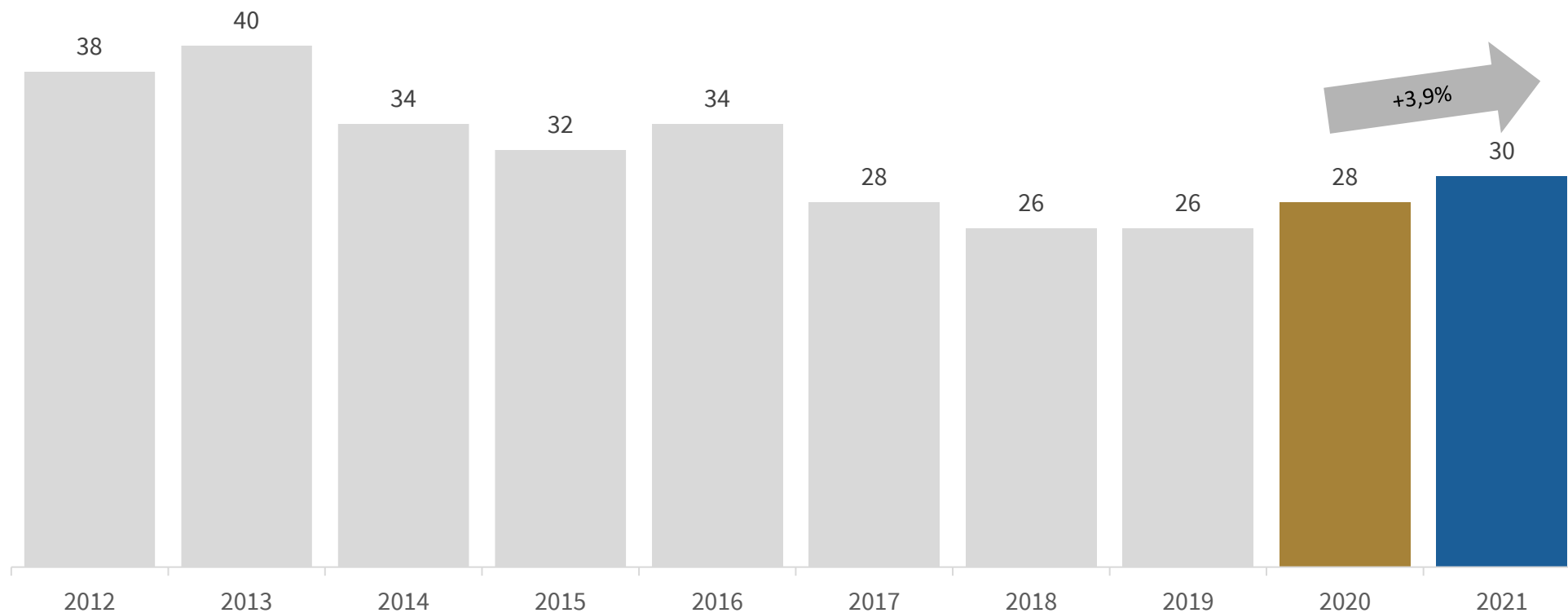
Imports of watches, clocks and parts by region² as a percentage of the total import value



Imports of watches, clocks and parts by region ² in million Euro



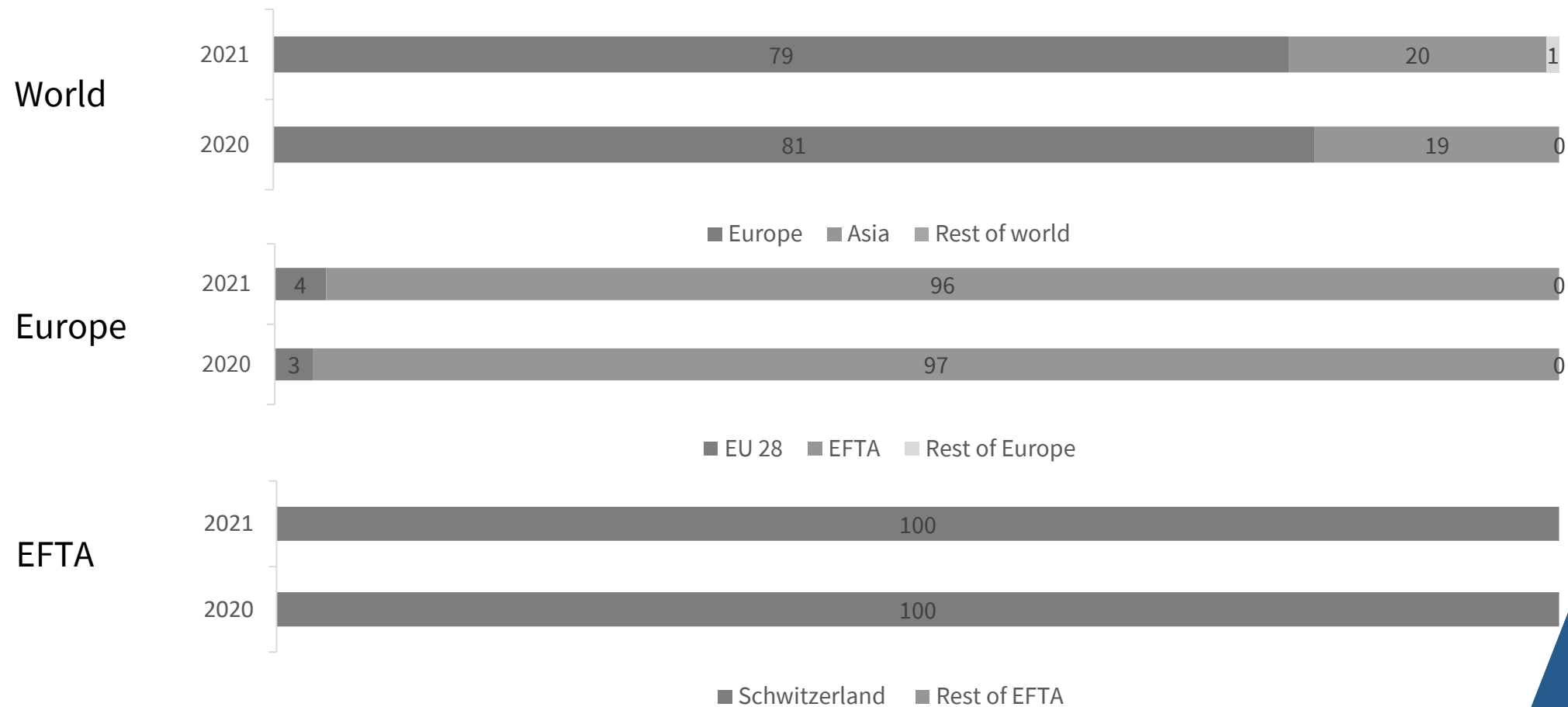
Imports of movements ^{2, 3} in million Euro

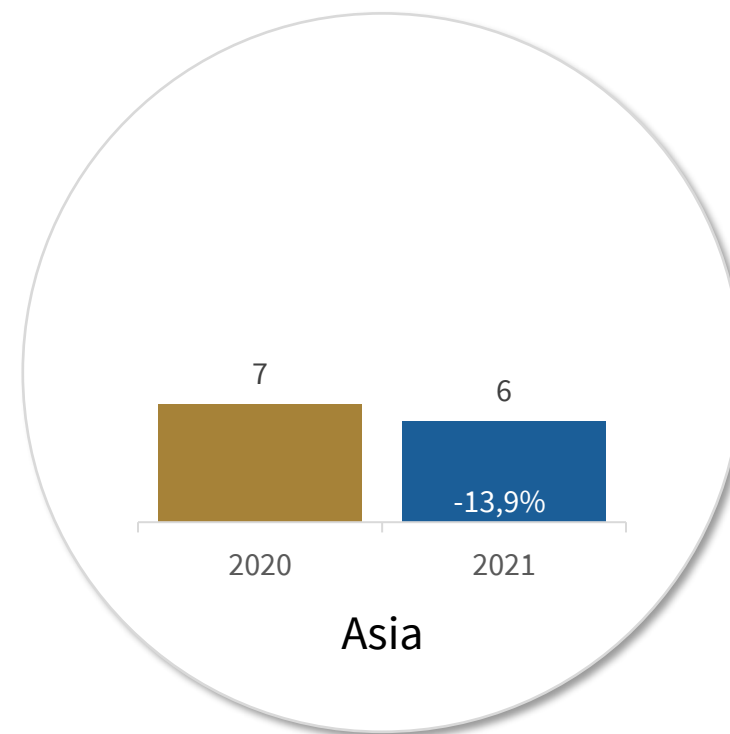
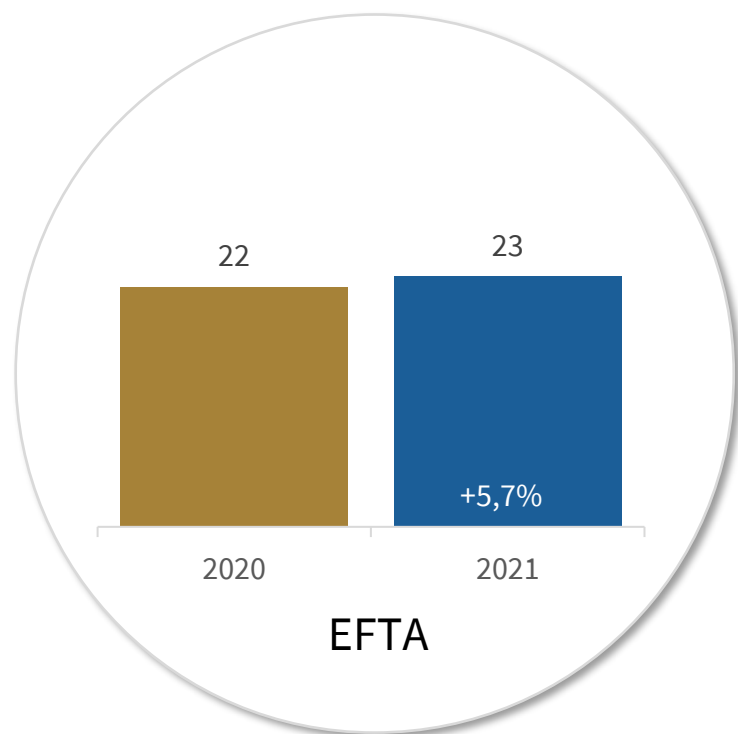
Imports of movements by region ^{2, 3} as a percentage of the total import value
