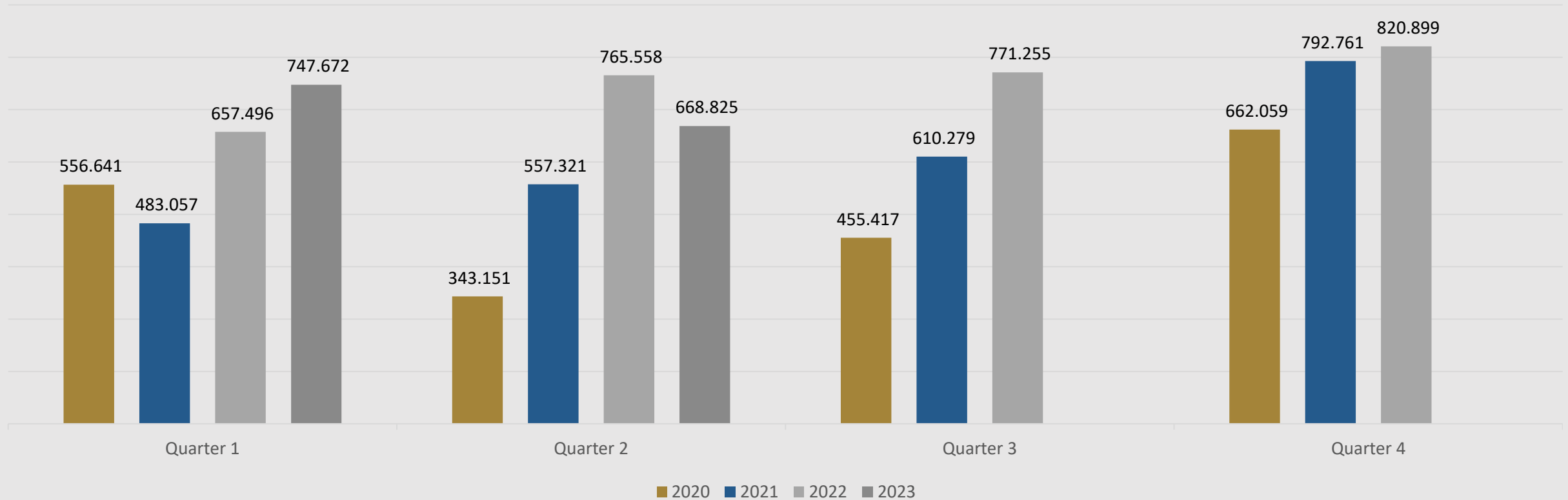

Quarterly basis in TSD Euro

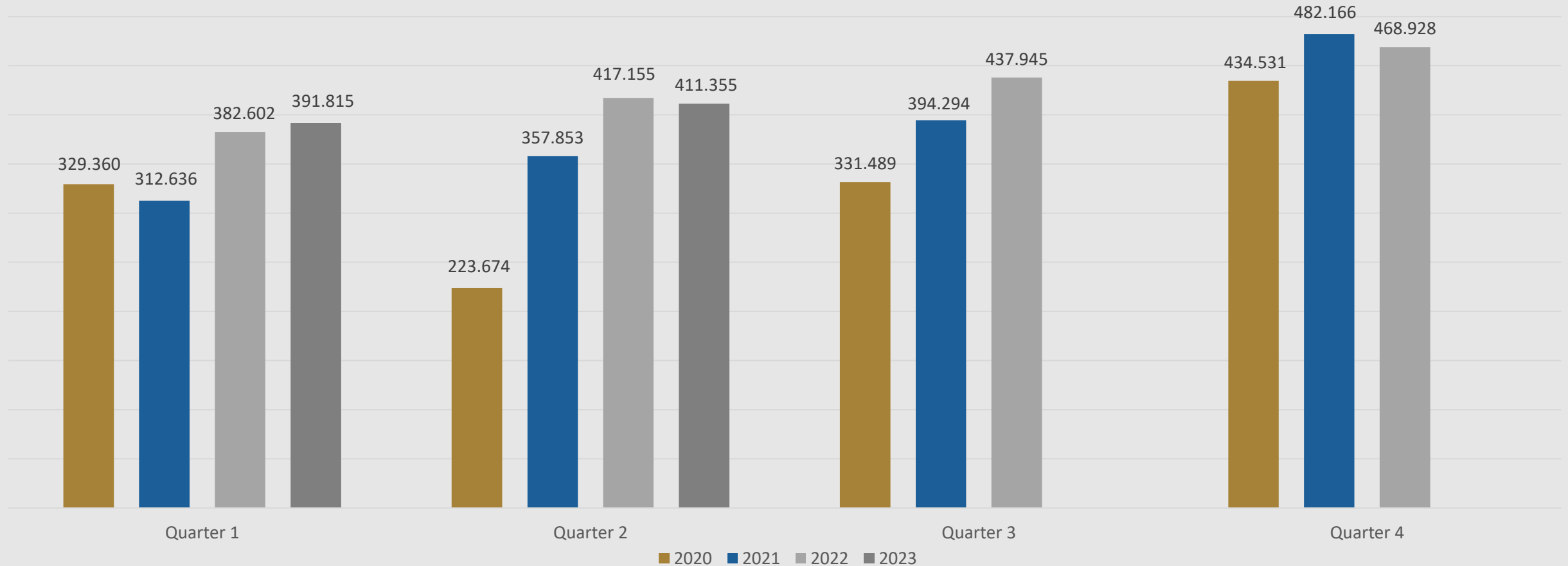

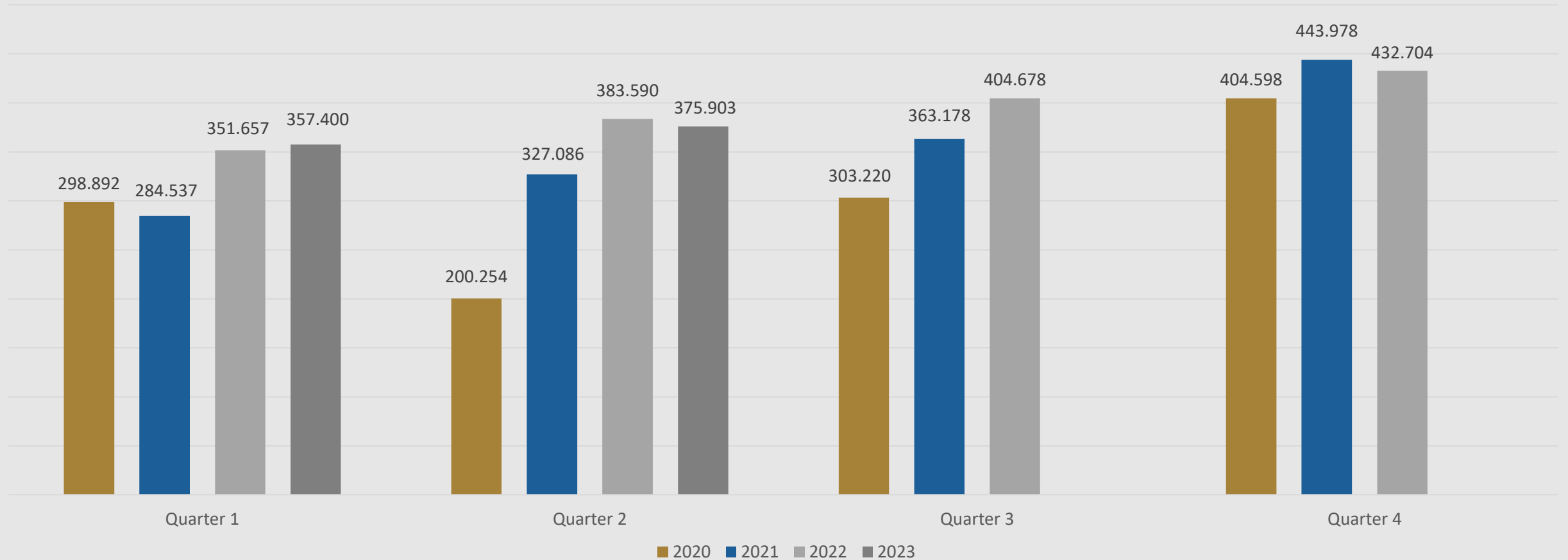

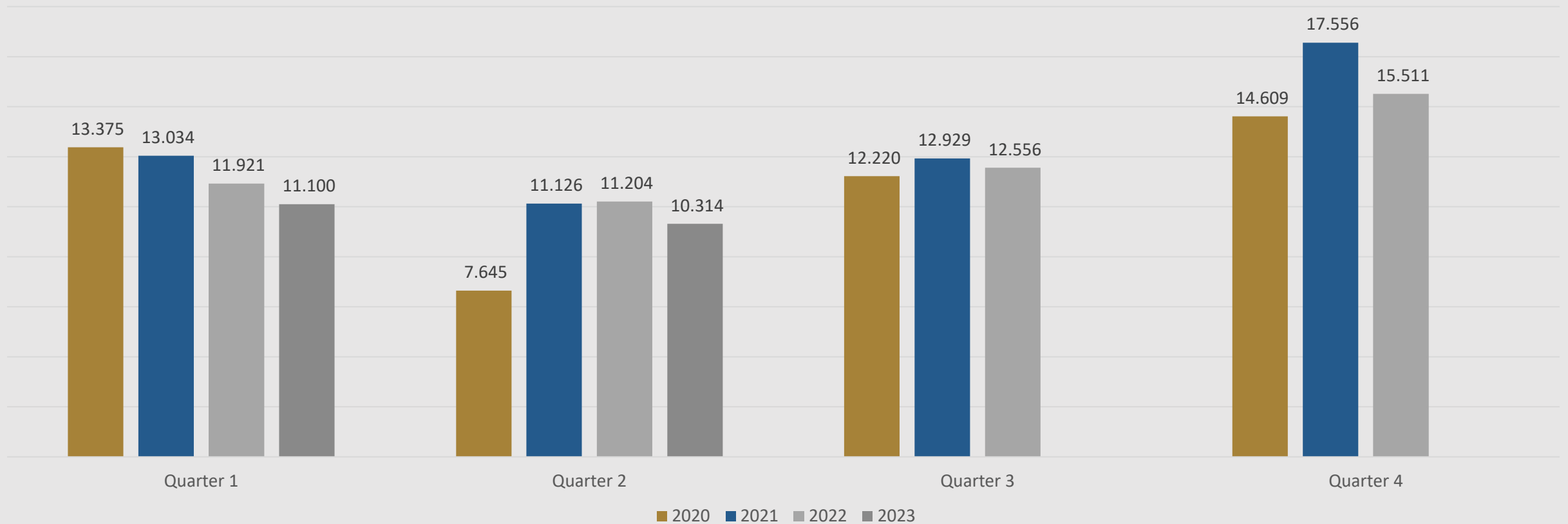

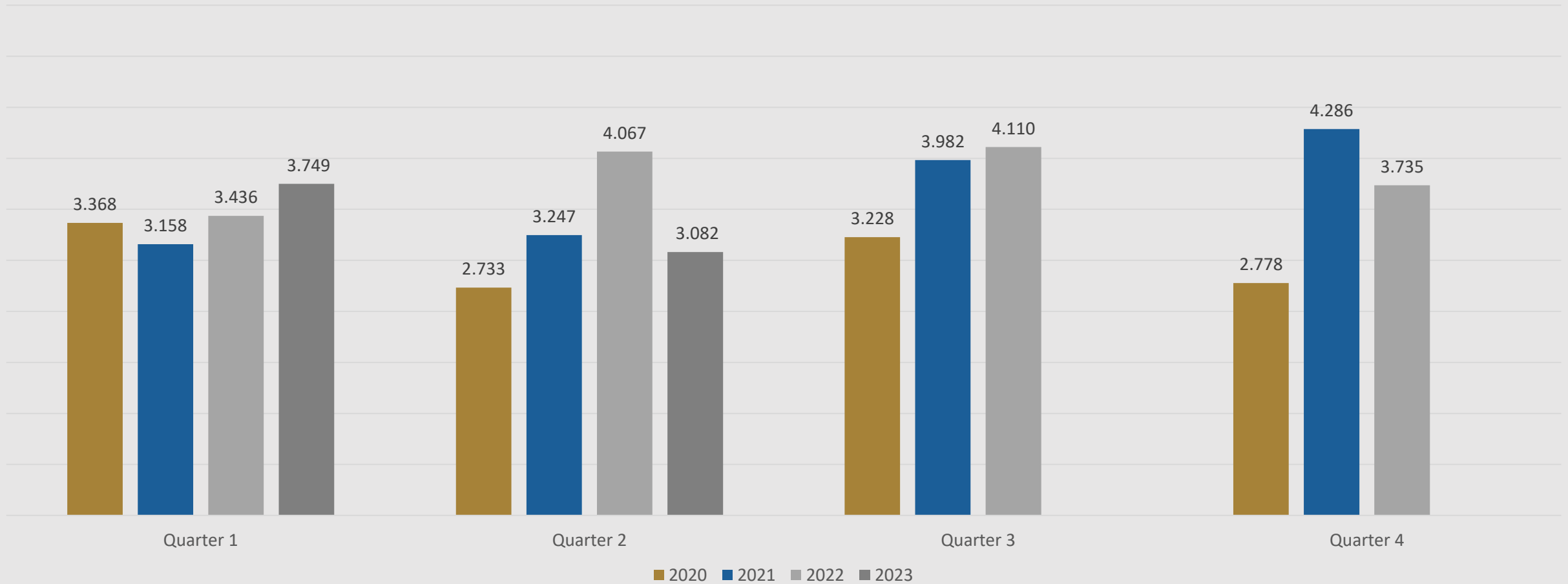

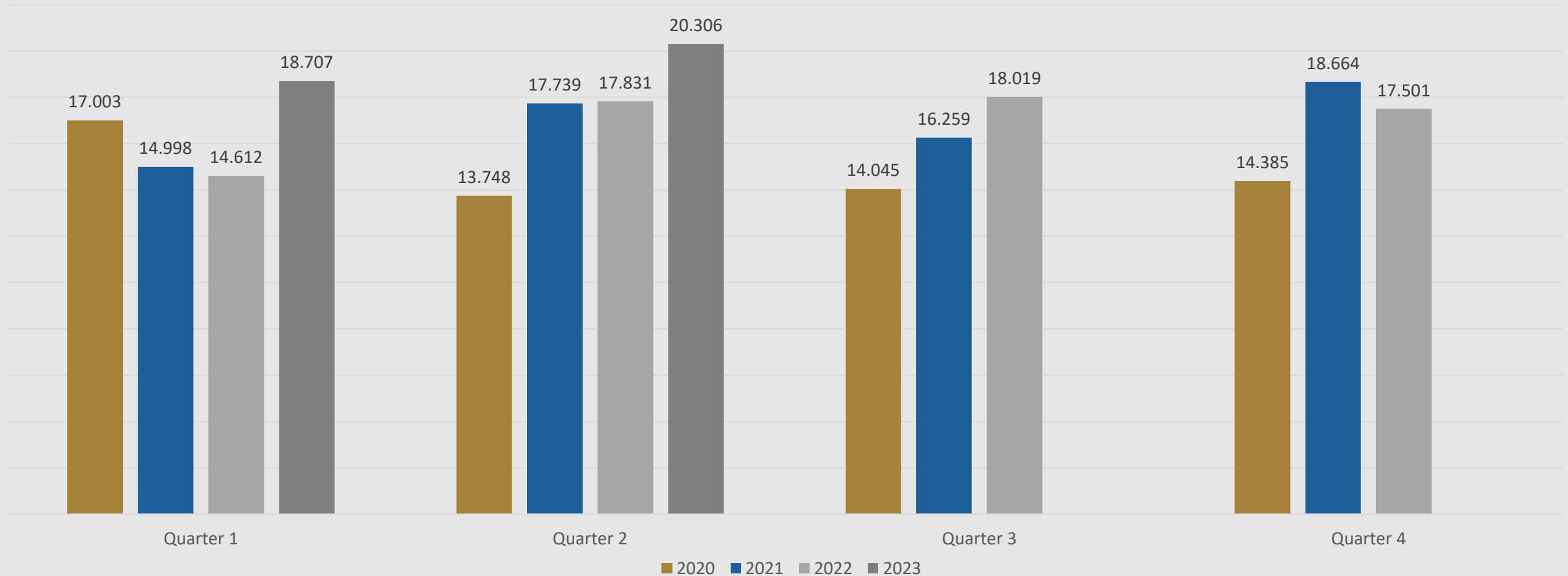

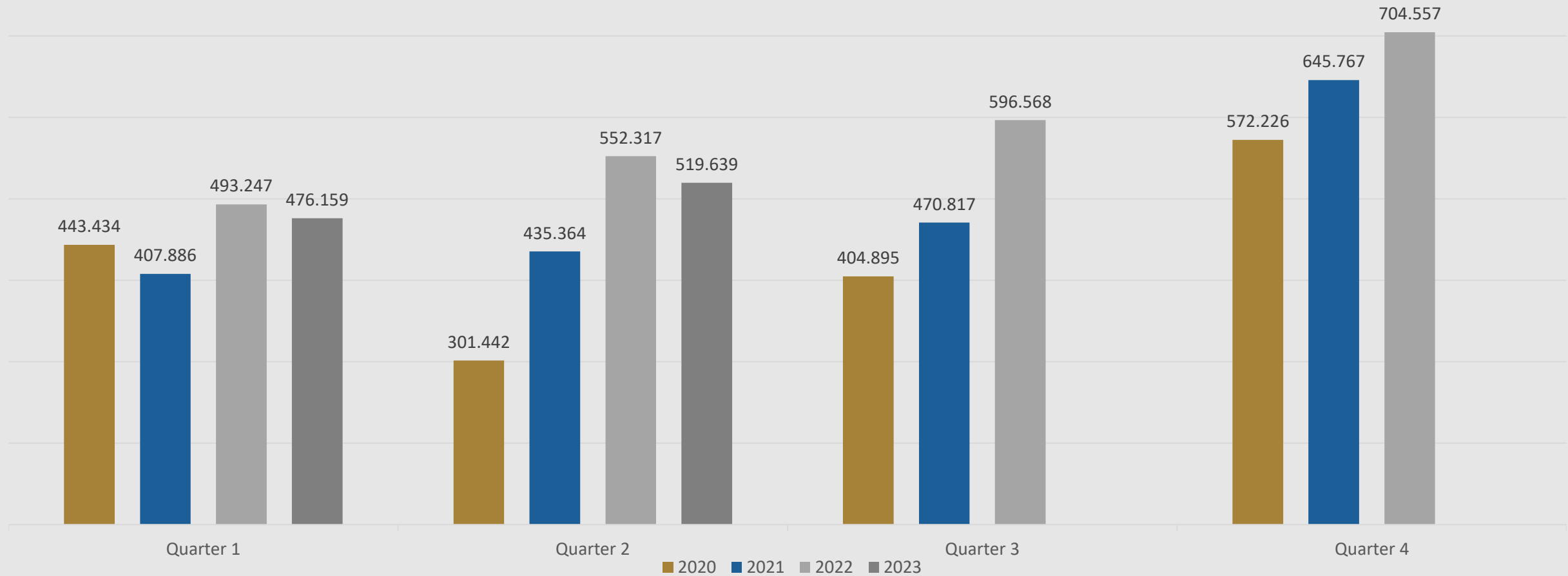

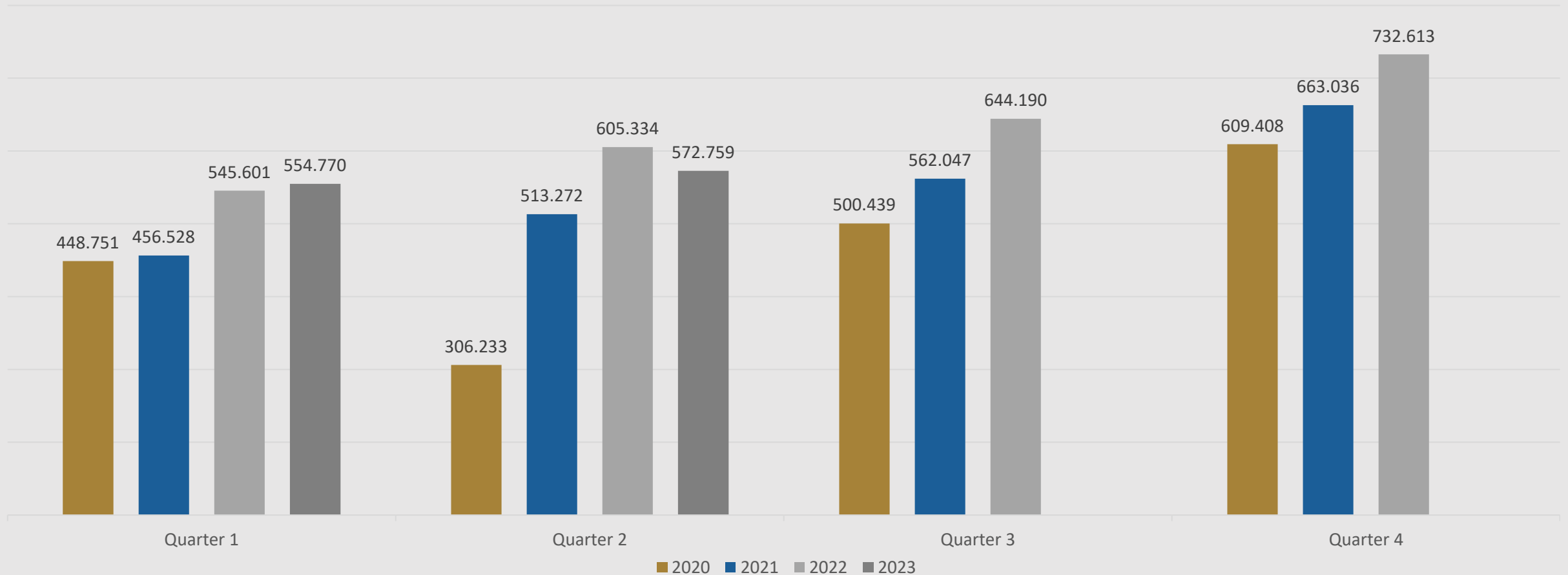

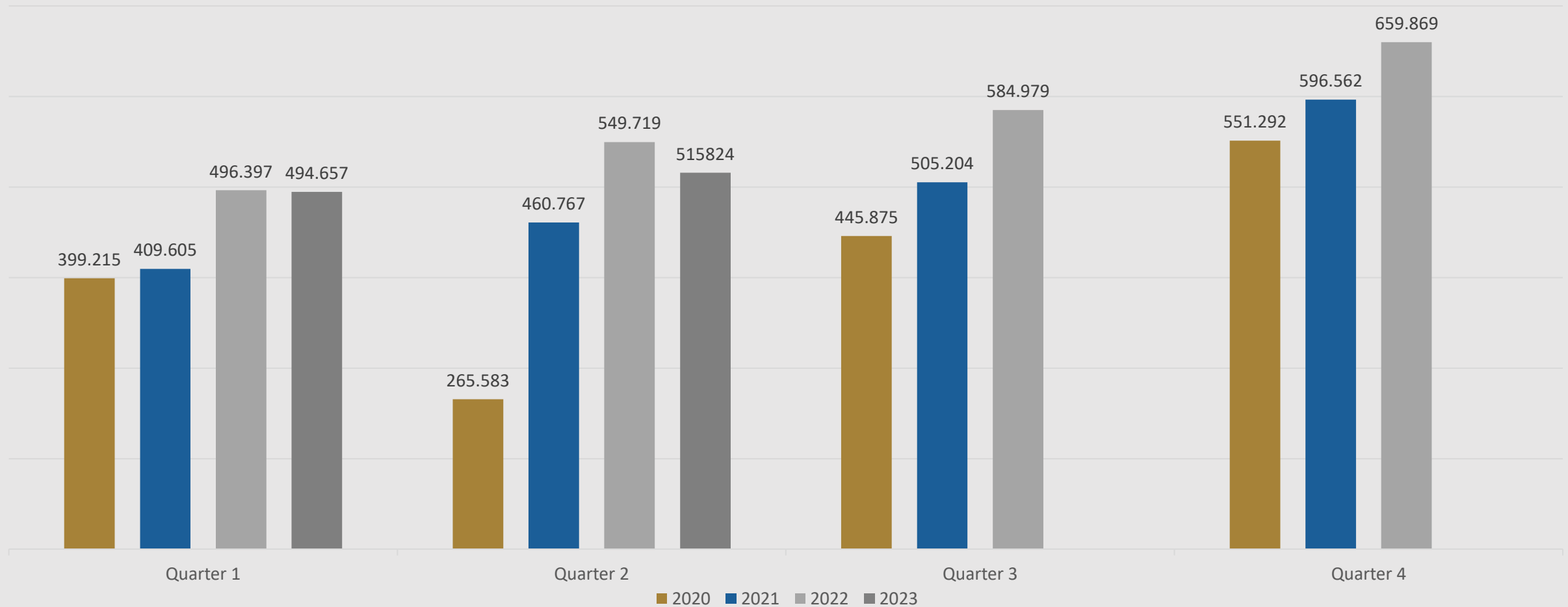

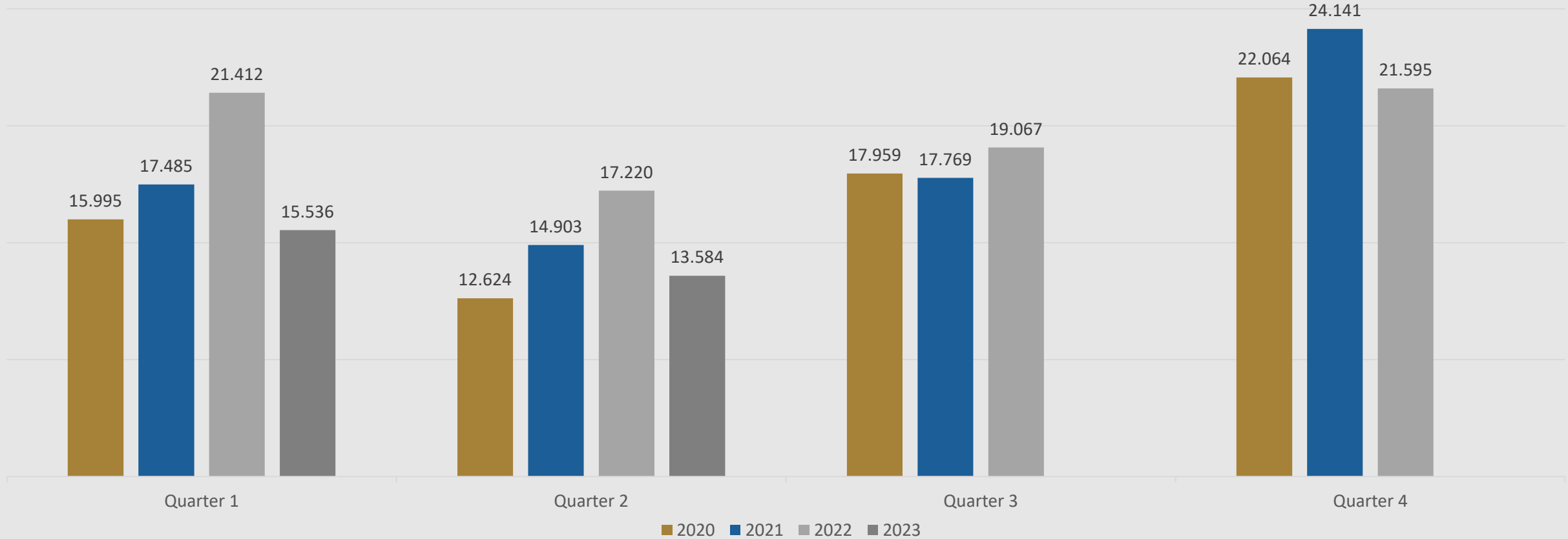

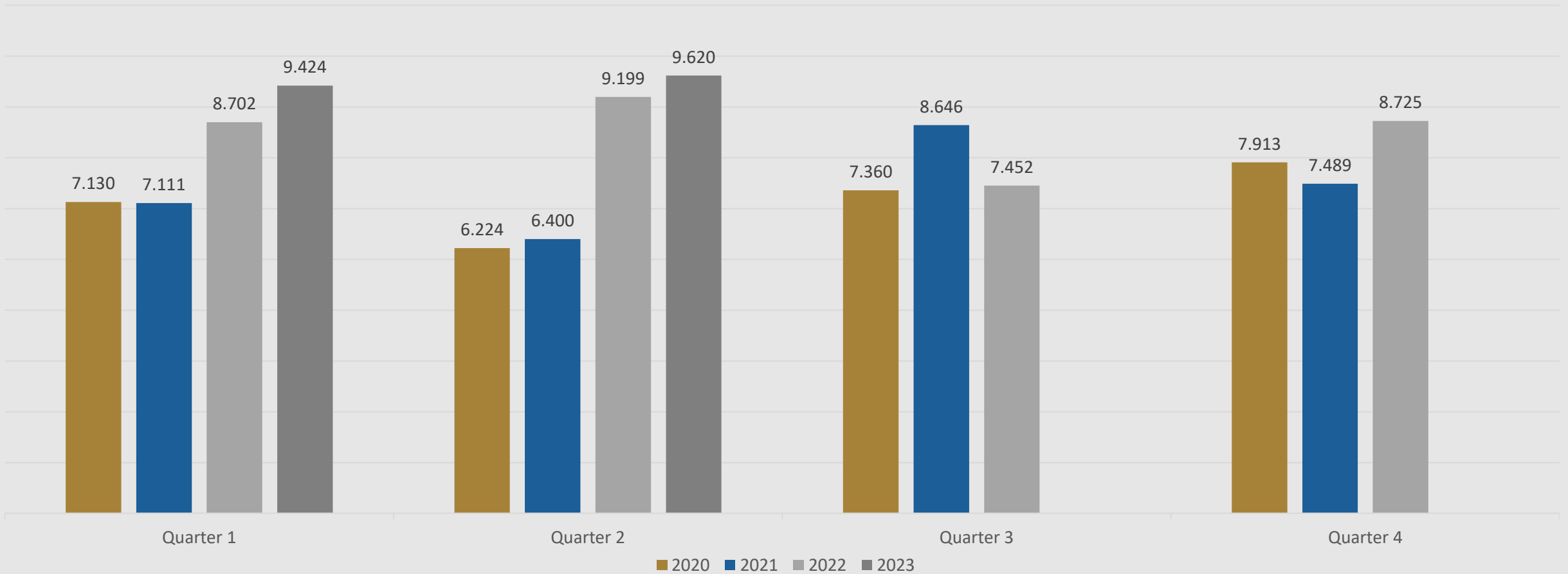

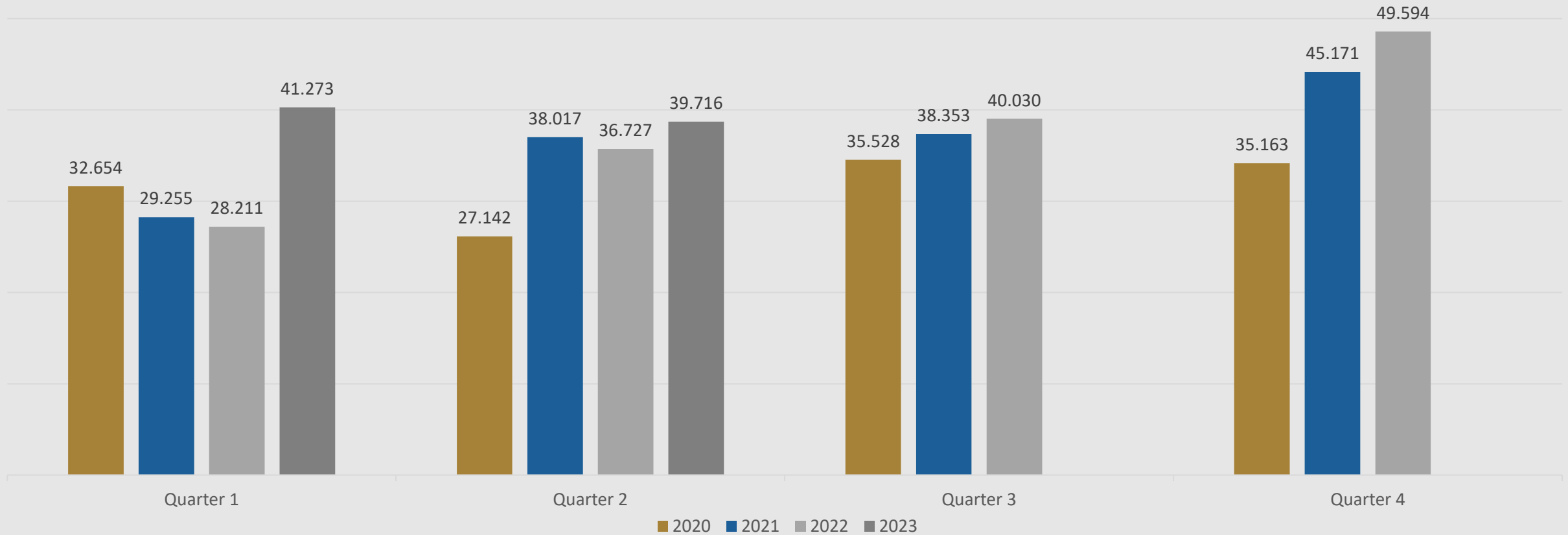
